Sr. No.	Name of the acts, rules, regulations etc.	Brief Gist of the Contents
1	The Maharashtra public Universities Act, 2016	All Universities in the State of Maharashtra are governed by the Maharashtra public Universities Act, 2016.
2	Maharashtra Civil Services Rules	Recruitment, appointment, Service conditions, leave rules, rules regarding conduct and disciplines etc., of non-teaching employees of the University.
3	Ordinances	Subject matters as prescribed under section 73 of the Maharashtra public Universities Act, 2016 such as tuition fees, students disciplines, conduct of examinations and such other matters required by or under the Maharashtra public Universities Act, 2016 or Statutes.
4	Statutes	Subject matters as prescribed under section 71 of the Maharashtra public Universities Act, 2016 such as establishment and maintenance of Departments, conduct of elections, procedures at meeting of various authorities of the Universities etc., and any other matter which is to be prescribed or which is necessary to give effect to the provisions of the Maharashtra public Universities Act, 2016.
5	Government Resolutions/Directions	Directions/Resolutions issued by the State Government, from time to time, as per section 5(63-83) of the Maharashtra public Universities Act, 2016.
6	Rules/Regulations	Rules relating to admission to Ph. D. degree, rules prescribing the eligibility criteria for admission to various courses and any other matter which by or under the Section 75 of the Maharashtra public Universities Act, 2016, Statutes or ordinances, are to be provided by the rules or regulations.

7	Guidelines of UGC/AICTE/NCTE/Bar Council of India etc.	Issued by UGC/AICTE/NCTE/Bar Council of India etc. from time to time, regarding conduct of professional courses, norms of standards of educations etc.
