ORDER

UNDER SECTION 14 (1) OF THE MAHARASHTRA UNIVERSITIES ACT, 1994

WHEREAS it has been noticed by the University that many of the affiliated colleges have not appointed any full time qualified approved Teacher/Principal as a consequence there to the academic standards are adversely affected, causing irreparable loss to the admitted students thereto;

AND

WHEREAS it is in fact mandatory for the management of the affiliated Colleges to appoint full time qualified approved teachers towards fulfillment of the prescribed conditions for grant/continuation of affiliation of the university in terms of provisions included at Section 81 of the Maharashtra Universities Act 1994(hereinafter referred to as Act)

AND

WHEREAS it is matter of reality that for years together the teaching activities in the affiliated colleges are being managed by appointing contributory teachers which is not congenial and conducive to the desired academic standards.

AND

WHEREAS the said non fulfillment of the binding conditions of affiliation stipulated under section 81 of the Act, which are not open for any waiver or condonation by affiliated colleges attract action to be taken by the University as contemplated U/S 91 of the Act.

Hence in exercise of the powers vested under Section 14(1) read with section 91 of the Act, the Hon'ble Vice-Chancellor, Gondwana University, Gadchiroli has issued orders that the Managements of all the affiliated colleges shall ensure appointment of at least one qualified full time approved Teacher per faculty and regular Principal before the commencement of academic session 2016-2017.

The compliance report regarding appointment of at least one full time qualified approved Teacher per faculty and regular Principal shall be submitted to the Registrar of the University on or before 31st May, 2016. It is also clarified that in the event of failure of the compliance there to within the stipulated period the deficient colleges shall not be permitted to admit students for first year of the courses run by them in the academic year 2016-2017 and resultantly no enrolments would be granted by the University.
