

The post of Director in the pay scale of Level 14 of Pay Matrix of Rs. 144200-218200 (Pre revised PB-4 (Rs. 37400-67000 with Grade Pay of Rs. 10,000) is proposed to be filled up in Vaikunth Mehta National Institute of Cooperative Management (VAMNICOM), Pune, a training unit of National Council for Cooperative Training (NCCT), New Delhi on deputation failing which on contract basis for a period of three years, through Search- cum-Selection process. National Council for Cooperative Training (NCCT) is a registered Society under the aegis of the Ministry of Agriculture & Farmers Welfare, Department of Agriculture, Cooperation & Farmers Welfare, Govt. of India to meet the changing requirement of human resource development in the Cooperative Sector in the country.

- (i) holding analogous post on regular basis in parent cadre or Department or
 - (ii) with three regular service in the scale of pay of Rs. 37,400-Rs. 67,000 with Grade Pay of Rs. 8700 in PB-4 (Pre-revised) or equivalent in parent cadre or Department.
3. The deputation with NCCT/VAMNICOM will be on Foreign Service terms and conditions.
4. The period of deputation (including short term contract) period of deputation in another ex-cadre post held immediately preceding this appointment, in the same or some other Organization/Department of the GOI shall ordinarily not exceed three years.
5. Officer selected will have the option to draw his pay plus deputation(duty) allowance or to have his pay fixed in the pay matrix of the post in accordance with the Department of Personnel & Training O.M. No. 6/8/2009-Estt.(Pay-II) dated 17-06-2010, as amended from time to time.
