#### NOTIFICATION

CONSTITUTION OF INDIA.

No. RR-2010/(67/10) TE-2.— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all existing rules, orders or instruments made in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the posts of Director of Technical Education, Joint Director of Technical Education or Director, Maharashtra State Board of Technical Education, Deputy Director of Technical Education or Secretary, Maharashtra State Board of Technical Education, Assistant Director (Technical) of Technical Education or Deputy Secretary, Maharashtra State Board of Technical Education of Maharashtra Education and Assistant Secretary of Maharashtra State Board of Technical Education of Maharashtra Engineering Administrative Services, Group-A on the establishment of the Directorate of Technical Education under the Higher and Technical Education Department of the Government of Maharashtra, namely :—

1. These rules may be called the Director of Technical Education, Joint Director of Technical Education or Director, Maharashtra State Board of Technical Education, Deputy Director of Technical Education or Secretary, Maharashtra State Board of Technical Education, Assistant Director (Technical) of Technical Education or Deputy Secretary, Maharashtra State Board of Technical Education Education, Assistant Secretary of Maharashtra State Board of Technical Education Maharashtra Engineering Administrative Service, Group-A (Recruitment) Rules, 2017.

2. In these rules, unless the context requires otherwise,—

(a) "AICTE" means All India Council of Technical Education, New Delhi, established under the All India Council of Technical Education Act, 1987 (52 of 1987);

(b) "Board" means the Maharashtra State Board of Technical Education;

(c) "Collective experience" means total experience gained in various fields of employments related to engineering or technical education;

(d) "Degree" means degree of a statutory University;

(e) "Department" means the Higher and Technical Education Department;

(f) "Director" means the Director of Technical Education under the Higher and Technical Education Department, Government of Maharashtra;

(g) "Directorate" means the Directorate of Technical Education, Maharashtra, under the Higher and Technical Education Department, Government of Maharashtra;

(h) "Government" means the Government of Maharashtra;

(i) "UGC" means the University Grants Commission established under section 4 of the University Grants Commission Act, 1956 (3 of 1956).

3. Appointment to the post of Director of Technical Education, Maharashtra State shall be made by nomination from amongst the following candidates, who,—

(i) are not more than fifty years of age :

Provided that, upper age limit may be relaxed up to five years in case of candidates already in service of Government;

(ii) possess Master's Degree in first class or an equivalent grade in a point scale wherever grading system is followed in Engineering or Technology duly recognized by AICTE and passed out from the institute affiliated to a University recognized by UGC;

(iii) possess Doctorate of Philosophy (Ph.D.) in Engineering or Technology from Indian or Foreign university or autonomous academic institutes duly recognized by UGC or have published minimum five research papers in referred International Journal:

(iv) possess experience of not less than twenty years either in the field of teaching at degree or diploma level in engineering educational institutes or in administration of technical education or collectively in these fields, gained after acquiring degree in Engineering or Technology :

Provided that, out of twenty years' experience, minimum five years administrative experience shall be on the post of Principal or Director of Polytechnic or Engineering College; or Head of Research Institute or Joint Director of Technical Education or Director, Maharashtra State Board of Technical Education; or Deputy Director of Technical Education or Secretary of Maharashtra State Board of Technical Education :

Provided also that, the candidate who has done research while teaching, in that case, the experience either of teaching or research shall be considered, for calculating the experience of teaching :

Provided also that, for the purpose of clause (iv), the appointment to the post of teacher at degree or diploma level in engineering educational institutes shall be duly approved by the concerned University or the Competent Authority, as the case may be.

4. Appointment to the post of Joint Director of Technical Education or Director, Maharashtra State Board of Technical Education shall be made either,—

(a) by promotion of a suitable person on the basis of strict selection with due regards to seniority from amongst the persons holding the post of Deputy Director of Technical Education or Secretary, Maharashtra State Board of Technical Education of not less than three years; or

(b) by nomination from amongst the following candidates who,—

(i) are not more than forty five years of age :

Provided that, upper age limit may be relaxed up to five years in case of candidates already in service of Government;

(ii) possess Master's Degree in first class or an equivalent grade in a point scale wherever grading system is followed in Engineering or Technology duly recognized by AICTE and passed out from the institute affiliated to a University recognized by UGC;

(iii) possess Doctorate of Philosophy (Ph.D.) in Engineering or Technology from Indian or Foreign university or autonomous academic institute duly recognized by UGC or have published minimum five research papers in referred International Journal;

(iv) possess experience of not less than fifteen years either in the field of teaching at degree or diploma level in engineering educational institutes or in administration of technical education or collectively in these fields, gained after acquiring degree in Engineering or Technology :

Provided that, out of the fifteen years' experience, minimum three years administrative experience shall be on the post of Principal or Director of Polytechnic or Engineering College or Head of Research Institute or Deputy Director of Technical Education or Secretary of Maharashtra State Board of Technical Education or Assistant Director of Technical Education or Assistant Secretary of Maharashtra State Board of Technical Education :

Provided also that, the candidate who has done research while teaching, in that case, the experience either of teaching or research shall be considered, for calculating the experience of teaching :

Provided also that, for the purpose of clause (iv), appointment to the post of teacher at degree or diploma level in engineering educational institutes shall be duly approved by the concerned University or the Competent Authority, as the case may be; or

(c) by transfer on deputation from amongst the persons holding the post of Principal or Professor in Government Engineering College or of Principal of Government Polytechnic :

Provided that, appointment by transfer on deputation shall be made in case the post cannot be filled in by promotion or by nomination :

Provided further that, the term and other conditions of appointment by transfer on deputation shall be as per deputation policy of State Government.

5. Appointment to the post of Deputy Director of Technical Education or Secretary, Maharashtra State Board of Technical Education shall be made either,—

(a) by promotion of a suitable person on the basis of strict selection with due regards to seniority from amongst the persons holding the post of Assistant Director (Technical) of Technical Education or Deputy Secretary, Maharashtra State Board of Technical Education of not less than three years; or

(b) by nomination from amongst the following candidates who,—

(i) are not more than forty five years of age :

Provided that, upper age limit may be relaxed upto five years in case of candidates already in service of Government;

(ii) possess Master's Degree in first class or an equivalent grade in a point scale wherever grading system is followed in Engineering or Technology duly recognized by AICTE and passed out from the institute affiliated to a University recognized by UGC;

(iii) possess experience of not less than ten years either in the field of teaching at degree or diploma level in engineering educational institutes or in administration of technical education or collectively in these fields, gained after acquiring degree in Engineering or Technology :

Provided that, the preference shall be given to the candidates have Ph.D. in Engineering or Technology from Indian or Foreign University or autonomous academic institute duly recognized by UGC or have published minimum five research papers in referred International Journal :

Provided also that, the candidate who has done research while teaching, in that case, the experience either of teaching or research shall be considered, for calculating the experience of teaching :

Provided also that, for the purpose of clause (iii), appointment to the post of teacher at degree or diploma level in engineering educational institutes shall be duly approved by the concerned University or the Competent Authority, as the case may be; or

(c) by transfer on deputation form amongst the persons holding the post of Associate Professor in Government Engineering College or of Head of Department in Government Polytechnic :

Provided that, appointment by transfer on deputation shall be made only in case the post cannot be filled in by promotion or by nomination :

Provided further that, the term and other conditions of appointment by transfer on deputation shall be as per deputation policy of State Government.

6. Appointment to the post of Assistant Director (Technical) of Technical Education or Deputy Secretary, Maharashtra State Board of Technical Education shall be made either.—

(a) by promotion of a suitable person on the basis of strict selection with due regards to seniority from amongst the persons holding the post of Assistant Secretary (Technical), Maharashtra State Board of Technical Education of not less than three years; or

(b) by nomination from amongst the following candidates who,—

(i) are not more than forty years of age :

Provided that, upper age limit may be relaxed upto five years in case of candidates already in service of Government;

(ii) possess Master's Degree in first class or an equivalent grade in a point scale wherever grading system is followed in Engineering or Technology duly recognized by AICTE and passed out from the institute affiliated to a University recognized by UGC :

(c) by transfer on deputation from amongst the persons holding the post of Assistant Professor in Government Engineering College or Lecturer in Government Polytechnic :

Provided that, appointment by transfer on deputation shall be made only in case the post cannot be filled in by promotion or by nomination:

Provided further that, the term and other conditions of appointment by transfer on deputation shall be as per deputation policy of State Government.

7. Appointment to the post of Assistant Secretary (Technical) of Maharashtra State Board of Technical Education in the Directorate may be made either,—

(a) by nomination from amongst the following candidates who,-

(i) are not more than thirty five years of age ;

(ii) possess Bachelor's Degree in first class or an equivalent grade in a point scale wherever grading system is followed in Engineering or Technology duly recognized by AICTE and passed out from the institute affiliated to a University recognized by UGC :

Provided that, preference shall be given to the candidates who possesses higher educational qualification in Engineering or Technology; or

(b) by transfer on deputation from amongst the persons holding the post of Lecturer in Government Polytechnic :

Provided that appointment by transfer on deputation shall be made only in case the post cannot be filled in by nomination.

8. Appointment to the posts mentioned in rules 4, 5 and 6 shall be made by promotion and nomination in the ratio of 50:50, respectively.

9. The persons appointed to the posts mentioned in rules 3, 4, 5, 6 and 7 by nomination shall be on probation for a period of two years. Probation period may be extended maximum upto one year. A person appointed to the posts shall be required to pass the prescribed Departmental **Examination** (if any) and to complete the probation period successfully within prescribed period. If he does not pass the prescribed Departmental Examination or does not complete probation period successfully or is not found suitable for the post then he shall be liable to be terminated from service.

10. The persons appointed to the posts mentioned in rules 3, 4, 5, 6 and 7 shall be required to pass the departmental examination and the examinations in Hindi and Marathi languages according to the rules made in that behalf, unless he has already passed or has been exempted from passing those examinations.

11. The persons appointed to the posts mentioned in rules 3, 4, 5, 6 and 7 should possess a certificate in computer operation prescribed by the Directorate of Information Technology, Government of Maharashtra from time to time.

12. The persons appointed to the posts mentioned in rules 4, 5, 6 and 7 shall be liable for transfer anywhere in the State of Maharashtra.
