· Eligibility for participation.

Team Composition.

The team may comprise of a maximum number of 2 members. A maximum of 3 entries are permitted from each institution.

· Registration.

The Students interested are required to send the duly completed registration form to mcs.svkm@gmail.com along with a scanned copy of a Demand Draft in favour of "PRAVIN GANDHI COLLEGE OF LAW", payable at Mumbai of Rs. 2000/- (per entry) (Two Thousand Only) as the registration fee. The hard copy of the same must be sent to SVKM's Pravin Gandhi College of Law, Mithibai College Campus, 8th Floor, Bhaktivedanta Swami Marg, Vile Parle (W), Mumbai- 400056.

The Participants have to register provisionally by sending an email to mcs.svkm@gmail.com by 20th February, 2020 before 16:00 hrs.

- > The length of the bill should not exceed 30 pages.
- > The cover page of the submission should include the Long Title of the bill along with the name of the Author(s), with the author's designation.
