WHAT ARE INTELLECTUAL PROPERTY RIGHTS:-

Patents:- Patent is an exclusive right granted by the Government to the applicant for his disclosed invention of product or process which should be new, non-obvious, useful and patentable. Patent offers technical solution to a technical problem.

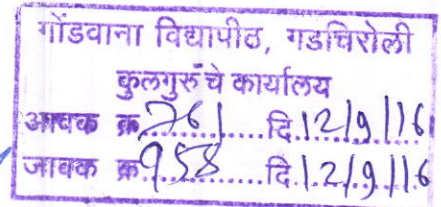
Designs:- Protecting any shape, configuration, pattern, color and the creations of the appearance of industrial products.

Trade Marks:- Trademark is a visual symbol in the form of word, name, logo, label etc. as applied to a vendible article, with a view to indicate origin of manufacture or service or vendor in that respect and enable customers to distinguish the product of one manufacturer from the goods of the other.

Geographical Indications: Geographical Indications of Goods are defined as that aspect of industrial property which refer to the geographical indication referring to a country or to a place situated therein as being the country or place of origin of that product. Typically, such a name conveys an assurance of quality and distinctiveness which is essentially attributable to the fact of its origin in that defined geographical locality, region or country.

Copyright: Copyright is a right given by the law to creators of literary, dramatic, musical and artistic works and producers of cinematograph films and sound recordings. It is a bundle of rights including rights of reproduction, communication to the public, adaptation and translation of the work. The exclusive and assignable legal right, given to the originator for a fixed number of years, to print, publish, perform, film, or record literary, artistic, or musical material.

Participants seeking "Student concession" in "training fees" shall provide a self-attested copy of Bonafide certificate from Institute OR self-attested copy of Identity card for the year 2016-17 from the respective Institute and should bring original at the time of training for verification.

75% concession in "training fee" for any organization / Department nominating **25 or more participants** for a single training program. Copy of self-attested valid Identity card of organization / letter for deputation from organization shall be provided. 25 or more officials or students, research scholars from same institute can also avail this concession.

50% fee concession in "training fee" for any organization / Department nominating **11 or more participants** for a single training program. Copy of self-attested valid Identity card of organization / letter for deputation from organization shall be provided. This concession will not be applicable to students, research scholars.

25% fee concession on "training fee" for any organization / Department nominating **5 or more participants** for a single training program. Copy of self-attested valid Identity card of organization or letter for deputation from organization shall be provided. This concession will not be applicable to students, research scholars.
