Trade Marks:- Trademark is a visual symbol in the form of word, name, logo, label etc. as applied to an vendible article, with a view to indicate origin of manufacture or service or vendor in that respect and enable customers to distinguish the product of one manufacturer from the goods of the other.

Geographical Indications: GI of Goods are defined as that aspect of industrial property which refer to the GI referring to a country or to a place situated therein as being the country or place of origin of that product. Typically, such a name conveys an assurance of quality and distinctiveness which is essentially attributable to the fact of its origin in that defined geographical Copyright: Copyright is a right given by the law to creators of literary, dramatic, musical and artistic works and producers of cinematograph films and sound recordings. It is a bundle of rights including rights of reproduction, communication to the public, adaptation and translation of the work. The exclusive and assignable legal right, given to the originator for a fixed number of years, to print, publish, perform, film, or record literary, artistic, or musical material.
