- The University may constitute a committee to look into the discrimination complaints received from the SC/ST/OBC Students /Teachers and non-teaching staff.

You are also requested to advise the officials/ faculty members of your university/ Institute to be more sensitive while dealing with incidents of caste discrimination, and provide the information as per the prescribed format, on the University Activity Monitoring Portal (UAMP) of UGC at link <a href="https://ugc.ac.in/uamp/">https://ugc.ac.in/uamp/</a>) latest by 25.09.2020.
