TERMS AND CONDITIONS FOR ESSAY COMPETITIONS IN THE CAUSE OF NATIONAL INTEGRATION AND COMMUNAL HARMONY

SCHEME:

Essay competitions for School Children and

College/University

Students.

2. FREQUENCY:

Annual

The topics of Essay should be selected every year from themes based on National Integration and Communa. Harmony. The topics should be decided by the State/UT Authorities, in consultation with the Departments of Secondary & Higher Education, Home, Finance and Planning, State University Grants Commission State Council for Higher Education etc.

Hindi/English or cff cial language of the State/UT.

(1) For \$chool Children: The children of secondary schools studying in Classes IX to XII are oligible to take part in this competition. This competition will be at district level and should be organized in the district with the delp of the district education establishment and the collector, who can set up a panel at judges for the selection of prize winning entries. The prize winning essays may be compiled and published in a book form. They may also be published in the local newspapers or magazines.

(ii) For College/University Students: The students studying in College/University are eligible to take part in this competition. This competition will be at State/UT level and should be organized by the State University Grants Commission in the State/UT. Where the commission has not been constituted as yet, it may be organized by the State Council for higher education or by the State Education Department. A panel of judges may be set up for the selection of prize winning entries. The prize winning essays may be compiled and published in a book form. They may also be published in the local newspapers or megazines.

- 6 HOLDING of ESSAY COMPETITIONS: Instructions/Govt orders may be issued to the concerned authorities to conduct the competition indicating details like date of receipt of entries by a specified date, date of competition etc. so that all formalities are completed well in time. The conduct of competition, evaluation of essays and final lists of awardees should be completed positively by 15. September every year.
- ANNOUNCEMENT of PRIZES: The name of the prize winning candidates may be announced by 2nd October every year to both the competitions by the State Governments/UT Administrations and District Authorities
- 8. <u>DISTRIBUTION of PRIZES:</u> The prizes may be given on the 26th January every year at the time of Republic Day Parade in the Districts for school children and in the State/UT Capitals for the College/University Students.
- 9. <u>TA/DA for PRIZE WINNERS:</u> The expenditure incurred by the recipients towards to and fro journeys performed to receive the prizes in second class by train/ordinary bus by shortest route and a lump sum amount of Rs.250/ (Rs. Two hundred and fifty only) towards boarding/lodging etc. may be reimbursed.
- 10. HONORARIA for PANEL OF JUDGES: An amount equal to 50% of the entire amount of prizes at district level Rs.1,000/- (Rs. One thousand only) per district and at State/UT level Rs.5,000/- (Rs. Five thousand only) per State may be paid as honoraria to the penal of Judges.

- 11. <u>ADMINISTRATIVE EXPENSES:</u> Administrative expenses like printing of certificates, compilation of prize winning essays etc. up to a maximum limit of Rs.500/- (Rs. Five bundred only) per district for school children and Rs.2,500/- (Rs. Two thousand & five bundred only) per State/UT for college/university students may be incurred.
- 12. REQUIREMENT of FUNDS: The Joint Secretary (HR), Ministry of Home Affairs, Lok Navak Bhavan Khan Market, New Delhi 110 003 may be informed in the prescribed proforma (Annexure-I) by 15th October every year the actual requirement of funds for competitions. The names of the State/UT Authorities in whose names the cheque/draft for the amount of prizes etc. is also to be sent together with a list of names of winners of the prizes. While calculating the fund requirement, the State/UT may include the payments of prize money. TA/DA for prize winners, honoraria for penal of Judges and administrative-expenses. The cheque/demand draft of the total requirement funds would be sent by payment to actual winner(s), provided requirement is received in time
- 13 MODE of PAYMENT: A single cheque/demand draft for all the admissible expenses and prize money would be drawn in the name of the authority nominated for the purpose by the State Government/UT Administration
- Utilisation CERTIFICATE: After the prizes are distributed to the winners, a the actual winners must be sent to the Ministry of Home Affairs by 31st March of the proforma (Annexure-II).
