This is with reference to the subject cited above, it is hereby notified to the all concerned applicants that, in order to recruit the vacant positions of Professor, Associate Professor and Assistant Professor in the University Post Graduate Teaching Departments an Advertisement was released on 20<sup>th</sup> March, 2020(Advt. No. 33/2020). As per said advertisement the last date of the submission of Application form was notified as on or before 20<sup>th</sup> April, 2020. However, to reduce the spread of epidemic Corona virus (Covid-19) the entire country has declared Lock Down until 14<sup>th</sup> April, 2020 except essential services. It has constrained the functioning of many of Government Departments. It is in this context, it has been noticed that those candidates who are eligible to the University teaching faculty advertisement No. 33/2020 are facing problems in submission of their application forms & Payment of fees. It is with reference to the Government of India's guideline as "work from home" the university directs to the all concerned applicants that, they can apply for the aforesaid advertisement of the university, in the online mode which has been developed by the University.

Thus, it is hereby directed to all concerned applicants that, by using the above university web-link can submit their application form online along with necessary application fees on or before 11/05/2020. It is directed to note that the posts reserved for VJ-A category are interchangeable to NT-B, NT-C & NT-D as per Govt. Resolutions. Online submission of application form alongwith fees is an additional facility provided to applicants.

In due course of time, the candidates have to submit the application form in eleven copies as per condition No. 39.

It is also directed to note that, the applicants should cautiously follow all specific guidelines while submitting their online applications in the prescribed format intended for the advertisement.
