Procedure for apply online for registration with CPCSEA

Website of CPCSEA: http://cpcsea.nic.in

- Step 1: It is required to sign up in the User Login Window available at Home Page. After submission of the Sign-up details, an Email will be sent to the user's Email.
- Step 2: The users (establishments) have to activate the link received on their Email.
- Step 3: The user is required to login through User Login Window at Home Page by selecting 'Establishment Login' in User type and put their User Name & Password which were entered during sign-up Form.

List of requisite documents for registration:

- i. Application as per revised Form 'A' for registration. (Each column of Form A is to be filled online).
- ii. The scanned copy of the DD of Rs. 1000/- as registration fee in favour of 'CPCSEA' payable at New Delhi is to be uploaded on the link mentioned and the hard copy of the same DD is to be sent to the O/o CPCSEA.
- iii. The Blueprint / Layout Plan of the Animal House Facility of the establishment, having the details of the various rooms with measurements for keeping animals, feed storage, wash room, office room etc as per CPCSEA guidelines, duly signed by the Head of the establishment and the Architect.
- iv. Minutes of the internal IAEC meeting, wherein recommendation for CPCSEA registration has been approved by the IAEC.
- v. Approval letter from the Government/ Autonomous Council (viz. AICTE/ PCI/MCI) or Company Registration Certificate.
- vi. The biodata and consent letters of 5 internal IAEC members (Biodata format available on the website).
