

# GONDWANA UNIVERSITY, GADCHIROLI

### Direction No. 18 of 2019

"Maximum or Minimum Intake for Admission to the Courses Leading to the Certificate or Diploma or Bachelor Degree or Post Graduate Diploma or Post Graduate Degree at the Affiliated Colleges of the University, Direction, 2019".

Whereas, the Maharashtra Public University Act 2016 has come into force with effect from, 1<sup>St</sup> March, 2017;

#### AND

Whereas, Section 37(1)(q) of the above said Act, empowers the Board of Deans to provide for the subject matters of Ordinances;

### AND

Whereas, Section 33(1)(g) of the above said Act, empowers the Academic Council to propose draft of Ordinances relating to the academic matter to the Management Council;

#### AND

Whereas, the State Government has permitted for number of courses leading to the Certificate, Diploma, Bachelor Degree, Post Graduate Diploma or Post Graduate Degree for its conduct in affiliated colleges of the University;

#### AND

Whereas, it was necessary to decide maximum and minimum intake for starting of the respective courses in an affiliated college;

#### AND

Whereas, Clause (n), (o) and (s) of sub section (1) of Section 33 provides that the Academic Council is competent to decide the subjects, courses of studies and the number of the student to be admitted to the courses, while granting affiliation to the colleges;

### AND

Whereas, above said Act, provides the conditions under which students shall be admitted to the courses of study for Degree, Diploma, Certificate and other academic distinction is a subject matter of an Ordinance;

#### AND

Whereas, no Ordinance is provided to decide maximum/minimum intake for admission to the Degree, Diploma, Certificate, courses conducted at an affiliated of the University and also the intake for admission to the additional section of the courses;

#### AND

Whereas, the matter is required to be regulated by the Ordinance;

#### AND

Whereas, making of an Ordinance regarding the matter mentioned in the subject at above is a time consuming process.

#### AND

Now, therefore, I Dr. N. V. Kalyankar, Vice- Chancellor, Gondwana University, Gadchiroli in exercise of the powers vested in me under the provision of Section 12(8) of the Maharashtra Public Universities Act 2016, do hereby issue the following Direction:

- 1. This Direction may be called 'Maximum or Minimum intake for admission to the course leading to the certificate or Diploma or Bachelor Degree or Post-Graduate Diploma or Post Graduate Degrees at affiliated colleges of the .University, Direction, 2019'
- 2. This Direction shall come into force with effect from the date of its issuance.
- 3. In this Direction, unless the context otherwise requires:
  - a) "Act" means the Maharashtra Public Universities Act 2016.
  - b) "Affiliated colleges" means a college/Institution which has been granted affiliation by the University.
  - c) "Continuation of Affiliation" means an affiliation for the courses of studies in the college or institution for which affiliation was granted by the procedure referred in relevant sections of the Act.
  - d) 'Extension of Affiliation' means an affiliation granted to an affiliated college or institution for adding courses of studies in the existing courses of studies.
  - e) "First time affiliation" means an affiliation granted by the Academic Council of the University to the new college or new Institution by following the prescribed procedure provided under relevant section of the Act.
  - f) "Academic year" means a year commencing on such a date and ending with such a date of the year following, as may be appointed by the management council in the academic calendar for the said year, to be prepared by it as per provisions specified in the relevant section of the Act.
- 4. Subject to the permission, decision, order, resolution of the state government prescribing or permitting maximum intake capacity otherwise, the maximum intake for admission in each initial year or each initial semester or each section of the corresponding year of the course leading to certificate, Diploma, Bachelor Degree, Post Graduate-Diploma, and Post Graduate Degree in affiliated colleges/ Institution of the University shall be as shown in Column No. 3 of the Table in Appendix- A of this Direction.
- 5. The minimum intake for admission in each initial year or each initial semester of the course leading to Certificate, Diploma, Bachelor Degree, Post- Graduate Diploma and Post Graduate Degree at affiliated colleges/ Institution in the University shall be as

per the ratio prescribed in Column No. 4 of the Table given in Appendix-B of this Direction.

- 6. The condition of maximum/minimum intake capacity for admission will be applicable to a newly started course if permission for starting the same is granted by the state government on or before 15<sup>th</sup> June of the year under consideration.
- 7. The maximum/minimum intake for the course not included in Appendix A of this Direction shall be as decided by the Academic Council of the University.
- 8. Where the requirement of maximum/minimum intake capacity prescribed here under is not fulfilled for any three consecutive years, after starting of the course/s, the University shall initiate action to de-affiliate the given course as per the procedure prescribed for the same. Where, however the requirement of minimum intake could not be fulfilled for unprecedented reasons, the same shall be taken into consideration by the Academic Council.
- 9. The conditions of minimum or maximum intake capacity, prescribed herein shall not be applicable to the courses where admission are made centrally as well as to the innovative professional courses, minimum competency courses, skill oriented courses and demand based courses permitted by the state or central government.
