## GONDWANA UNIVERSITY GADCHIROLI Ordinance No. 44 of 2017.

Examinations leading to the Certificate course in Library and information Science (six month duration Course) in the faculty of Social Sciences, Ordinance, 2017.

Whereas, it is expedient to provide an ordinance in respect of Examination leading to the Certificate course in Library and information Science, (Six month duration course) in the faculty of Social Sciences, for the purposes hereinafter appearing, the Management council is hereby pleased to make the following ordinance:

- 1. This ordinance may be called "Examinations leading to the Certificate Course in Library and information science (Six month duration course), in the faculty of social sciences. Ordinance, 2017.
- 2. This ordinance shall come into force with effect from the date of its making by the Management council.
- 3. The duration of Library and Information Science Certificate course will be one year and there will be university examination at the end of academic session.
  - 4. Subject to his compliance with the provisions of this ordinance and of any other ordinances in force from time to time an applicant for admission to:

## C. Lib.I.Sc. - Examination shall:

i) Have Passed the Higher Secondary School

Certificate Examination of the Maharashtra state
Board of Secondary Education in any division or
an examination recognized as equivalent there to
with English as one of the subjects of passing and
such subjects and with standards of attunements as
may be prescribed, and

- Have, since passing the Higher Secondary School
  Certificate examination, prosecuted a regular
  course of study for a period not less than 6 months
  in any recognized institute.
- 5. The examination leading to the Certificate course in library and information science shall be held twice a year at such places and on such dates as may fixed by the university.
  - 6. The examination fee shall be as prescribed by the university from time to time.
  - 7. The scope of subjects shall be as indicated in the syllabus.
  - 8. The number of papers/practical and the maximum marks assigned to each papers/practical and the maximum marks an examinee must obtain in order to pass the examinations shall be as indicated in appendix B appended with this ordinance.
  - 9. An examinee that either does not pass or fail to present himself the examination shall be eligible to appear at any subsequent examination without prosecuting a regular course of study.
  - 10. An examinee failing the examination but obtaining not less than 40% of the marks in theory part of the subject shall be exempted from appearing at subsequent examination in

that subject.

- i) Examinee securing 50% or more marks in practical part of the examination shall be exempted from appearing in that part at a subsequent examination.
- ii) An examinee passing the examination as a whole in the minimum, prescribed period and obtaining the prescribed number of places in the first or second division shall be arranged in order of merit.
- 11. The examinee who are successful in the bachelor of Library and Information science examination and have obtain 60% or more marks in the aggregate of the B.Lib.I.Sc. examination shall be placed in the first division, those obtaining less than 60% but not less than 50% shall be placed in the second division.
- 12. Provisions of ordinace award of grace marks for passing an examination, securing higher division/class and for securing distinction in the subject (s) shall apply to the examination.
- 13 Notwithstanding anything contrary in this ordinance, no persons shall be admitted to this examination, if he has already passed the same from this university or of any other statutory university.
- 14. Examinee's successful at the final examination shall on payment of the prescribed fees, be entitled for the award of the degree in the prescribed from signed by the Vice-Chancellor.

## (Statement of object and reasons)

The Vice-chancellor of the university had issued Direction No. 143 of 2012 on 26/6/2012 in respect of Direction governing the examinations leading to the Certificate Course in Library and Information Science (Six month duration course) in the faculty of social sciences, under provision of section 14 (8) of the Maharashtra university Act, 1994.

The subject matter of the Direction is required to be regulated by an ordinance as provided under the Act.

Inview of the above, the existing Direction is required to be converted into an ordinance as provided under the Act, hence this Draft ordinance is prepared for consideration of the Academic council and the Management council.
