# SGONDWANA UNIVERSITY GADCHIROLI Ordinance No.53 of 2017.

#### Qualifying Norms for Passing in a particular head of Passing for all the Courses (Yearly and Semester Pattern with Credit Grade System) of all the Faculties, ordinance, 2017.

Whereas, it is expedient to provide an ordinance in respect of qualifying norms for passing in a particular head of passing for all the courses (yearly and semester pattern with credit grade system) in all the faculties, for the purposes hereinafter appearing, the Management council is hereby pleased to make the following ordinance:-

- This ordinance may be called "Qualifying Norm for Passing in a particular head of Passing for all the Courses (Yearly and Semester Pattern with Credit Grade System) in all the Faculties. Ordinance, 2017"
- 2. This ordinance shall come into force w.e.f. its making by the management council.
- 3. The internal and external assessment of student performance incorporates a suitable evaluation scheme based on their performance in different methodological tests/examinations as mentioned below:
  - For Theory Subjects/Courses, continuous assessment shall have various components of evaluation as Internal Assessment (IA) or College Assessment (CA) or Internal Evaluation (IE), Mid Semester Examination (MSE), End Semester Examination (ESE) and any such relevant component of evaluation.
  - For Practical/Laboratory Courses, continuous assessment shall have various components of internal and external evaluations like College Assessment (CA), University Assessment (UA), Term Work (TW), Performance and Oral Examination (POE) and any such relevant component of evaluation.
  - Depending on the course of study, these components shall be put together required for qualifying the given head of passing with a weightage as prescribed in the relevant ordinance of the given course of study.
- 4. Subject to the requirement of qualifying norms in a particular head of passing viz theory or practical subjects of the given course under all the Faculties shall be as under:
  - The students shall have to obtain the minimum prescribed passing marks for the given theory subject or practical which shall consist of all the components of evaluation taken together i.e. the internal/college assessment and the university assessment shall not be considered as separate head of passing.

- 5. For Absentees in Internal /College Assessment
  - If a given student fails to appear in various components of evaluation pertaining to College/Internal Assessment, the Principal of the respective college should forward such candidates IA/CA to the Affiliating University before declaration of the concerned examination result.
- 6. Aforesaid prescribed qualifying norms shall be applicable for all the heads of passing of the given course of study of the relevant Faculty
- 7. Provisions appearing in different ordinance, which are not consisted with the provisions made in this ordinace shall stand repealed.

#### (Statement of object and reasons)

The Vice-chancellor of the university had issued Direction No. 158 of 2013 on 1/3/2013 in respect of Direction processing qualifying Norms for Passing in a particular head of Passing for all the Courses (Yearly and Semester Pattern with Credit Grade System) of all the Faculties, under provision of section 14 (8) of the Maharashtra university Act, 1994.

The subject matter of the Direction is required to be regulated by an ordinance as provided under the Act.

Inview of the above, the existing Direction is required to be converted into an ordinance as provided under the Act, hence this Draft ordinance is prepared for consideration of the Academic council and the Management council.
