OPERATION OF BEQUESTS, DONATIONS AND ENDOWMENTS FOR AWARDING MEDALS/PRIZES AND ANY OTHER DISTINCTIONS FOR ALL THE EXAMINATIONS(AMENDMENT) ORDINANCE, 2017.

Whereas, it is expedient to amend ordinance no. 59 of 2017 in respect of operation of Bequests, Donations and Endowments funds for awarding Medals/Prizes and any other distinctions for all the examinations, Ordinance, 2017, for the purposes hereinafter appearing, the Management Council is hereby pleased to make the following ordinance:-

- 1. This Ordinance Shall be called "Operation of Bequests, Donations and Endowments for awarding medals/prizes and any other distinctions for all the examinations(Amendment), Ordinance, 2017."
- **2.** This Ordinance shall come into force with effect from the date of its making by the Management Council.
- **3.** In the title of an Ordinance in respect of Operation of Bequests, Donations & Endowments for awarding Medals/ prizes and any other Distinctions for all the examinations i.e. Ordinance No. 59 of 2017,(hereinafter referred to as the Main Ordinance) the worlds "for all" appearing after the word "distinctions" before the words " the Examinations" be substituted by the word "in".
- **4.** In the 1 st para of the main Ordinance, the words "for all" appearing after the words "for all" appearing after the word "Distinctions" and before the words "the Examinations" be substituted by the word "in".
- **5.** In Clause "(xii)" of para "3" of the main Ordinance
 - i) At the top of the table, the word "TABLE" be inserted at the centre.
 - ii) Below the title of each column of the table and before the line at the top of the entries in the column, the following columnwise entries be inserted.

- iii) The words and signs 'First merit in Final year B.A. (Geography) appearing in Column No. 4 against Sr. No. 17 in list under the table be substituted by the words and sign "securing highest marks in Geography at Bachelor of Arts Degree examinations.(All examinations in the subject be taken together)"
- iv) The words and signs "First merit in overall Final year B.A." appearing in Column No 4 against Sr. No. 19 in the list under the table be substitute by the words and signs "Securing highest marks in Psychology at Bachelor of Arts Degree examinations (All examinations in the subject be taken together)".
- v) The words and signs 'Adv. Shri. Vijay Ganpatro Mogre' appearing in Column No. 2 of list against Sr. No.20 in the list under the table be substituted by the words and signs "Mrs. Smita Vijay More".
- vi) The words and signs "First merit in Final year B.Sc. from amongst girl students" appearing in Column No. 4 if the list under the table against Sr. No. 20 be substituted by the words and signs "Securing highest marks in Music at Bachelor of Arts Degree examinations. (All examinations in the subject be taken together)".
- vii) After the entire against Sr. No. '24' in the table, the following columnwise entries be added:-
