DIRECTION RELATING TO THE EXAMINATION LEADING TO THE DEGREE OF MASTER OF COMPUTER APPLICATION, SEMESTER PATTERN WITH CREDIT GRADE SYSTEM (AMENDMENT) DIRECTION, 2016.

Whereas, Direction no. 111 (A) of 2014 in respect of direction relating to examination leading to the degree of Master of Computer Application, semester pattern with credit grade system is in existence in the university.

AND

Whereas, the eligibility for admission to M.C.A. 1st year (semester I & II) is provided wrongly as First year/Second year to the three year M.C.A. course to the candidates having Bachelor Degree namely B.C.A., B.C.S., B.Sc. (Computer/information Technology).

AND

Whereas, All India council for Technical Education, New Delhi has provided in the Approval process Handbook 2013-2014 that the B.C.A., B.Sc. (I.T./Computer Science) Bachelor Degree holder shall be admitted to M.C.A. programme in the second year which shall be treated as Lateral Entry.

AND

Whereas, Director of Technical Education, Maharashtra State, Mumbai vide his letter No. 2 A /ADM/M.C.A./2013/1350 dated 05 Oct. 2013 has informed the direct admission to second year of the three M.C.A. programme.

AND

Whereas, Dean, Faculty of Science and Chairman, Board of studies in Computer Science vide their letter dated 16.11.2015 has informed that the Lateral Entry is applicable for the batches of 2013-14 & 2014-2015 only.

AND

Whereas, some student holding B.C.A. & B.Sc. (I.T./computer) Bachelor Degree are considered eligible for the IInd year M.C.A. programme for the batch of 2013-14.

AND

Whereas, the result of the student mentioned in above para, are yet to be declared for want of eligibility to be provided in the existing Direction.

AND

Whereas, the matter is required to be regulated by an Ordinance.

AND

Whereas, making of an Ordinance is the time consuming process.

AND

Whereas, to resolve the problem, it is necessary to amend the existing Direction.

AND

Now, therefore, I, Dr. N.V. Kalyankar, Vice-Chancellor, Gondwana University, Gadchiroli in exercise of the powers conferred upon me vide section 14(8) of the Maharashtra Universities Act, 1994 do hereby issue following directions to amend existing Direction No. 111 (A) of 2014.

- 1. This Direction may be called "Examinations leading to the degree of Master of Computer Application, semester pattern with credit grade system (Amendment) Direction, 2016."
- 2. This Direction shall come into force from the date of its issuance.
- 3. In para.6, of Direction No. 111 (A) of 2014 in respect of Direction relating to the examination leading to the degree of Master of Computer Application, semester pattern with credit grade system (hereinafter referred to as the main Direction)
 - a) In line 6 of sub para. 2 of para. 6 of the main Direction the sign and words "/ second year" be deleted.
 - b) The provision of this para. shall now be applicable for the 2015-16 & onward batches.
- 4 In para. 7 of the main Direction. following sub para. be added which shall be applicable for the batches admitted in 2013-14 & 2014-15

or

"Candidates who have passed Bachelor of computer application (B.C.A.) and Bachelor of Science (Computer/Information Technology) Degree courses with Mathematics as a course at 10 + 2 level or at graduate level with 50% (45% in case of candidates belonging to reserved category) at qualifying examination shall be eligible for second year of three year full time post graduate degree course i.e. (M.C.A.)."
