(Issued u/s. 12 (8) of the Maharashtra Public Universities Act, 2016.)

LIST OF SUBJECTS COMPRISED IN EACH FACULTY IN THE UNIVERSITY DIRECTION, 2019.

(Under section 34 (3) of the Maharashtra Public Universities Act, 2016.)

Whereas, the Maharashtra Public Universities Act, 2016 has been made applicable to the Gondwana University, Gadchiroli with effect from 1st March 2017(Hereinafter referred to as the Act.);

AND

Whereas, section 34 (2) of the Act provides that the University shall have faculties namely, Faculty of Science and Technology, Faculty of Commerce and Management, Faculty of Humanities, and Faculty of Inter-Disciplinary Studies;

AND

Whereas, the Vice-Chancellor, under provision of section 12 (8) of the Act, has issued Direction for prescribing the faculties in the University which are provided under the Act;

AND

Whereas, sub-section (3) of section 34 of the Act provides that each faculty shall comprise of such subjects as prescribed by the Statutes;

AND

Whereas, original Statute 19 in respect of List of subjects comprised in each faculty in the University of Rashtrasant Tukdoji Maharaj Nagpur University, Nagpur was made applicable to the Gondwana University, Gadchiroli;

AND

Whereas, original Statute 19 in respect of List of subjects comprised in each faculty in the University was passed taking into consideration the existence of the then ten faculties in the University;

AND

Whereas, the Act has provided only Four Faculties, in view of which the provisions made under original Statute 19 were inconsistent with the provisions made under the Act;

AND

Whereas, the Academic Council in its meeting held on 30/05/2017 Vide item No. 33 on the Agenda has resolved to merge the existing faculties in the University into the newly provided four faculties by the Act;

AND

Whereas, while resolving the merger of existing ten faculties in the University into newly provided four faculties by the Act, the Academic Council had authorized the Vice-Chancellor to make suitable changes on the basis of the instructions/ guidelines to be issued from the State Government, while merging the faculties;

AND

Whereas. the Joint Secretary, Higher and Technical Education Department, Government of Maharashtra vide Letter No. Sankirn-2017/P.K. 279/UE-3 dated 22nd June 2017 had issued guidelines for merging of the old faculties into the faculties provided under the Act;

AND

Whereas, considering the guidelines received from the State Government, the merging of the then ten existing faculties into the newly provided Four faculties by the Act changes were to be made;

AND

Whereas, in the light of guidelines received from the State Government, each faculty provided under the Act was to be allotted the subjects which were previously allotted to the then existing faculties in the University;

AND

Whereas, the matter relating to the subjects comprised in each faculty is required to be regulated by the Statutes;

AND

Whereas, the provisions made under the existing original Statutes 19 relating to list of subjects comprised in each faculty in the university were inconsistent with the provision made for the faculties in the Act and the guidelines received from the State Government;

AND

Whereas, the University had to conduct the elections of the Boards of studies comprised in each faculty in the University;

AND

Whereas, for preparing the electoral Roll of teachers for election of two teachers representing each faculty on the Academic Council and for creating the Boards of studies in each faculty in the University, it was necessary to prepare a sub-ordinate legislation namely, 'List of subjects comprised in each faculty in the University', to regulate the matter.

AND

Whereas, Direction No. 10 of 2017 in respect of List of subjects comprised in each faculty in the university Direction, 2017 was issued by the Vice-Chancellor under provision of section 12 (8) of the Maharashtra Public Universities Act, 2016, on 07/07/2017;

AND

Whereas, it was necessary to convert Direction No. 10 of 2017 into the statute as provided under the proviso of sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016;

AND

Whereas, Draft statute No. 24 of 2017 in respect of list of subjects comprised in each faculty in the university Statute, 2017 was passed by the Senate Vide item No. 6 on the agenda papers in its meeting held on 27/03/2018;

AND

Whereas, Draft Statute No. 24 of 2017 was submitted to the Honorable Chancellor for his assent under provision of section 72 (4) of the Maharashtra Public Universities Act, 2016 vide letter No. GU/Regi./9218/2018 dated 12/11/2018;

AND

Whereas, Draft Statute No. 24 of 2017 is yet to be assented to by the Honorable Chancellor;

AND

Whereas, Desk Officer, Higher and Technical Department, Maharashtra Government vide letter No. GUG-18/C.N. 146/UE-2 dated 11/01/2019 informed the undersecretary (Educational) of the office of the secretary of the Governor that Draft statutes submitted by the university were placed before the committee constituted under provision of Government Resolution No. Sankirna – 2015/C.N. 219/15.UE – 3 dated 12/10/2017 under the Chairmanship of the Director, Higher Education, Pune which has recommended to approve Draft Statute No. 24 of 2017;

AND

Whereas, order of assent to Draft Statute No. 24 of 2017 by the Honorable Chancellor is yet to be received in the university.

AND

Whereas, Direction No. 10 of 2017 in respect of list of subjects comprised in each faculty in the university Direction, 2017 automatically lapsed with effect from 06/07/2017 as per provision made under the proviso of sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016.

Now, therefore, I, Dr. N. V. Kalyankar, Vice-Chancellor, Gondwana University, Gadchiroli in exercise of the powers conferred upon me under provision of sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016, do hereby issue following Directions.:-

- This Direction may be called "List of subjects comprised in each faculty in the University Direction, 2019."
- 2. This Direction shall come into force from the date of its issuance.
- Each faculty namely, 1) Science and Technology, 2) Commerce and Management,
 Humanities, and 4) Inter-disciplinary studies, in the University shall comprise such subjects as mentioned under the name of the faculty in the <u>Schedule</u> annexed with this Direction.
- original Statute 19 in respect of 'List of subjects comprised in each Faculty under the university', of R.T.M. university, Nagpur which was made applicable to the Gondwana University, Gadchiroli, shall stand repealed with effect from 07/07/2017.
