

GONDWANA UNIVERSITY, GADCHIROLI

Direction No. 25 of 2022

"Direction Prescribing procedure to conduct elections to the authorities of the University namely, the Senate, the Academic Council, and the Board of Studies at the Polling centers appointed by the University (Amendment) Direction, 2022".

(Issued under provision of section 12 (8) of the Maharashtra Public Universities Act, 2016.)

Whereas, the Maharashtra public Universities Act, 2016 has come into force with effect from 1st March 2017. (Maharashtra Act No. VI of 2016) (hereinafter referred to as the Act),

AND

Whereas, the Act has been made applicable to the Gondwana University. Gadchiroli from the date of its coming into force i.e. from 1st March 2017,

AND

Whereas, Section 28(2)(p) of the above mentioned Act provide as follows;

"Six representatives of Management - to be elected from among the collegium of management representatives of the affiliated colleges or institutions out of whom one shall be from Scheduled Castes or Scheduled Tribes or Denotified Tribes (Vimukta Jatis) or Nomadic Tribes or Other Backward Classes category, by rotation, and one shall be woman:

Provided that, such representatives of management to be elected shall be the representatives of management of colleges which are accredited by National Assessment and Accreditation Council or National Board of Accreditation as the case may be:

Provided further that, where a management conducts one or more Colleges or institutions, only one representative of such management shall be eligible for being included in collegium of Management Representatives"

AND

Whereas, above mentioned provision of the Act is required to be regulated by preparing the Statute;

AND

Whereas, making a Statue is a time consuming process;

AND

Whereas, to regulate the above mentioned provision, the Direction under provision under section 12(8) of the Maharashtra Public Universities Act, 2016 is required to be issued;

Whereas, Direction No. 15 B of 2022 appended with Direction No. 15 of 2022 in respect of "Procedure for the election of Six representatives of Management of the Affiliated colleges or institutions to the Senate (under provision of Section 28(2)(p) of the Act) Direction, 2022", was issued by the Vice-Chancellor, provision of which is not consistent with the relevant provision of the Act;

Now, therefore, I, Dr. P. S. Bokare, Vice-Chancellor of Gondwana University, Gadchiroli in exercise of powers conferred upon me under sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016, do hereby direct as under;

- 1) This Direction may be called, "Direction Prescribing procedure to conduct elections to the authorities of the University namely, the Senate, the Academic Council, and the Board of Studies at the Polling centers appointed by the University (Amendment) Direction, 2022".
- 2) This Direction shall come into force from the date of its issuance.
- 3) The following sentences appearing in para 6 of *Direction No. 15 B of 2022* in respect of "Procedure for the election of Six representatives of Management of the Affiliated colleges or institutions to the Senate (under provision of Section 28(2)(p) of the Act) Direction, 2022" shall hereby stand deleted.

"Management representative of such management which had its management representative on the immediately preceding Management Council of the university shall not be eligible to contest the election"
