# Sondwana UNIVERSITY, GADCHIROLI.

## Direction No. 12 of 2024

PROCEDURE TO BE FOLLOWED BY THE UNIVERSITY FOR GRANT OF APPROVAL TO ISSUE NOTICE OF TERMINATION TO TEACHER OF AN AFFILIATED COLLEGE UNDER STATUTE 53, DIRECTION, 2024.

(Issued u/s 12(8) of the Maharashtra Public Universities Act, 2016)

**Whereas**, the Maharashtra Public Universities Act, 2016 (Maharashtra Act No. VI of 2017) (hereinafter the "Act of 1994"), has come into force w.e.f. 1<sup>st</sup> March 2017, and the same has been made applicable to the Gondwana University, Gadchiroli (hereinafter the "University");

#### AND

**Whereas**, the Maharashtra Universities Act, 1994 came to be repealed as per the provisions of section 147 (1) of the M.P.U. Act, 2016, however, by virtue of the provisions of section 147(2)(I) all Statutes made under the repealed Act will continue to be in force to the extent to which they are not inconsistent with the provisions of the Maharashtra Public Universities Act, 2016;

#### AND

Whereas, as per the provision of Statute 53 framed under the Nagpur university Act, 1974, prior approval of the Executive Council of Nagpur University was mandatory for issuing notice of termination to a confirmed teacher in an affiliated college;

#### AND

Whereas, the Maharashtra Public Universities Act, 2016 replaces the Executive council, with another body called ,Management Council, constituted under section 30 of the Act and the same is conferred with powers and duties under section 31 of the said Act;

#### AND

Whereas, in terms of the provision of section 71 (20) of the Act, a statute prescribing condition of service of teachers of affiliated colleges can be made by the University and statute 53 of the Nagpur University(now Rashtrasant Tukadoji

Maharaj Nagpur University) is applicable to the Gondwana University according to which for termination of service of teachers of an affiliated college prior approval of the Executive Council of the University (now management Council) is necessary.

### AND

Whereas, it is expedient to prescribe procedure for grant of approval to issue notice of termination to the confirmed teachers of affiliated colleges as per para 5 of Statute 53,, by framing an appropriate statute but since making of a statute is a time consuming process Direction No. 08 of 2019 entitled" PRESCRIBING THE PROCEDURE TO BE FOLLOWED BY THE UNIVERSITY FOR GRANT OF APPROVAL TO ISSUE NOTICE OF TERMINATION TO TEACHER OF AN AFFILIATED COLLEGE UNDER STATUTE 53, DIRECTION, 2024."was issued by the University which has since lapsed by virtue of the provision of proviso to section 12(8) of the Act necessitating issuance of a fresh Direction incorporating the provisions of the said lapsed Direction;

**Now,** therefore, I, Dr. Prashant Bokare, Vice-Chancellor, Gondwana University, Gadchiroli do hereby issue the following Directions by exercising powers vested in me under provision of section 12 (8) of the Maharashtra Public Universities Act, 2016: -

 This Direction may be called, "PROCEDURE TO BE FOLLOWED BY THE UNIVERSITY FOR GRANT OF APPROVAL TO ISSUE NOTICE OF TERMINATION TO TEACHER OF AN AFFILIATED COLLEGE UNDER STATUTE 53, DIRECTION, 2024."

This Direction shall come into force from the date of its issuance.

"

Provided that in those cases where final action by the Management /College Development committee/Principal on the basis of the university approval has not come in force, shall also be covered by the present Direction.

In this Direction, unless the context otherwise requires:-

- a) "Act" means the Maharashtra Public Universities Act, 2016.
- **b)** "College Development Committee" means the committee duly constituted as per Section 97 (1) of the Act,
- **c)** "Management" means the management as defined as per section 2 (37) of the Act;
- d) "Management Council" means the Management Council of the University constituted under section 30(4) of the Act,;
- e) "Statute 53" means Statute 53 framed by the R.T.M. Nagpur University under the provisions of N.U. Act, 1974 which is being in force by virtue of the provisions of section 147 (2)(I) of the Act, ;
- 4. Every proposal submitted by the Management/college Development Committee/ Principal of the affiliated college for grant of approval for issuing notice of termination to a confirmed teacher as contemplated under para 5 of Statute 53 shall be placed for consideration of the Management Council and the decision in that behalf will be taken by the Management Council of the University.
- 5. In order to evaluate the proposal, the Management Council shall constitute a sub-committee of not less than 3 persons(total number of members of the committee shall, however, be an odd number) and after receipt of the proposal by the university, every such proposal shall be placed for consideration by the Registrar before the sub-committee constituted by the Management Council.
- 6. The sub-committee shall evaluate the proposal with regard to the following issues.
  - a) Whether the action initiated against the confirmed teacher by the Management/College Development Committee/Principal of the college was bonafide and was not actuated by malice.
  - b) Whether the requisite opportunity was granted by the enquiry officer to the teacher in the proceeding so as to comply with the minimum requirements of the principals of natural justice, and
  - c) Whether the proposed punishment is proportionate to the degree of misconduct proved against the teacher.
- 7. It would be competent for the sub-committee to issue notice to the Management/College Development Council/Principal as well as to the teacher concerned for producing on record any additional document, if felt necessary, and it would also be within the authority of the sub-committee to hear the parties in case it is felt necessary by it.

- After evaluating the proposal and after collecting such additional material 8. as would be deemed necessary by the sub-committee, the sub-committee shall make recommendations in writing to the Management Council with regard to the said proposal clearly stipulating their in whether the university should not grant approval to the proposed action along with the requisite reasons there for.
- The recommendations of the sub-committee shall be placed for 9. consideration before the Management Council and the Management Council shall take the final decision on the basic of the recommendations of the sub-committee. It would be competent for the Management Council to over-rule the recommendations of the sub-committee for the specific reasons to be recorded in that behalf.
- After the decision of the Management Council in the matter, the Registrar 10. of the University shall communicate the decision of the Management Council to the concerned Management/Principal under his signature.
- The university shall Endeavour to decide the proposal finally within a 11. period of six months from the date of receipt of the proposal, as far as possible.
- If the university finally refuses the approval for the proposed action, it 12. would be obligatory on the concerned Management/Principal to revoke the action initiated against the concerned teacher within 15 days from the

date of receipt of the communication from the university.
