**DIRECTION NO. 221 OF 2016.**

**DIRECTION TO PROVIDE FOR THE PROCEDURE FOR REVALUATION, RETOTALLING & SUPPLY OF CERTIFIED PHOTO/XEROX COPIES OF ASSESSED ANSWER BOOKS TO THE EXAMINEES ON DEMAND (AMENDMENT), DIRECTION, 2016.**

(Issued under provision of Sub-Section (8) of section 14 of the Maharashtra Universities Act, 1994)

**Whereas** the Maharashtra Universities Act, 1994, i.e. Maharashtra Act No. XXXV of 1994, has come into force with effect from 21<sup>st</sup> July 1994.

**AND**

**Whereas**, the above mentioned Act has been made applicable to the Gondwana University, Gadchiroli from the date of establishment of the University;

**AND**

**Whereas**, Direction No. 152 of 2012 in respect of Direction to provide for the procedure for revaluation, retotaling and supply of certified photo/Xerox copies of assessed answer books to the examinees on demand was issued by the Vice-chancellor under provision of Sub-section (8) of section 14 of the above mentioned Act;

**AND**

**Whereas**, procedure for making application for photo/Xerox copies is prescribed under para 5 of Direction No. 152 of 2012;

**AND**

**Whereas**, corrigendum to Direction No. 152 of 2012 was issued by the then acting Vice-chancellor on 23/12/2012 vide No. Acad/1342/2014 for extension in the date for submission of an application;

**AND**

**Whereas,** non-refundable fees of Rs. 300 per answer book for providing Photocopy was prescribed in Direction No. 152 of 2012;

**AND**

**Whereas,** the Management council, in its meeting held on 7<sup>th</sup> October, 2016, vide item No. 3 on the Agenda, has resolved for restructuring of the fees relating to photo/Xerox copies of answer book and for challenge to valuation by an examinee;

**AND**

**Whereas,** fees for photo/Xerox copies of an answer book is to be re-structured in the light of the resolution of the Management council meeting dated 7/10/2016;

**AND**

**Whereas,** fees re-structured by the Management council for photo/Xerox copies of answer book and for challenge to valuation are to be executed for the examination, conducted by the university in winter 2016.

**AND**

**Whereas,** the matter is required to be regulated by an ordinance and existing Direction No. 152 of 2012 is yet to be converted into an ordinance;

**AND**

**Whereas,** converting the Direction No. 152 of 2012 into an ordinance is time consuming process;

**AND**

**Whereas,** the matter relating to fees is to be executed for an examinees appeared in winter 2016 examinations

**AND**

**Whereas,** considering the emergency of regulating the matter for the time being, it is necessary to amend Direction No. 152 of 2012 to regulate the matter.

**Now,** therefore, I, Dr. N. V. Kalyankar, Vice-chancellor, Gondwana University, Gadchiroli, in exercise of the powers vested in me under provisions of sub-section (8) of section 14 of the Maharashtra Universities Act, 1994, do hereby issue following Directions to amend Direction No. 152 of 2012:-

- 1) This Direction shall be called “Direction to provide for the procedure for revaluation, retotalling and supply of certified photo/Xerox copies of assessed answer books to the examinees on demand (Amendment), Direction, 2016.”
- 2) This Direction shall come into force w.e.f. the date of its issuance.
- 3) In clause (viii) of para 5 of Direction No, 152 of 2012 in respect of “Direction to provide for the procedure for revaluation, retotalling and supply of certified photo/Xerox copies of assessed answer books to the examinees on demand” (hereinafter referred to as the main Direction.)
  - i) the figure and sign “300/-“ be substituted by the figure & sign “250/-“
  - ii) the word “books”, appearing in second line, be substituted by the word “book” ; and
  - iii) the word “Account” be substituted by the word “Accounts”;
- 4) In clause V of para 9 of the main Direction :-
  - i) the figure & sign “500/-“ be substituted by the figure and sign “200/-“;
  - ii) the word “paper” be substituted by the words “answer book”.
  - iii) the words “Account and” be deleted; and
  - iv) after the word “Finance” and before the word “Officer”, the words “ and Accounts” be inserted.
