DIRECTION NO. 222 OF 2016.

DIRECTION GOVERNING ONSCREEN REVALUATION OF ANSWER BOOK OF EXAMINEE APPEARING OF THE UNIVERSITY EXAMINATION,(AMENDMENT), DIRECTION, 2016.

(Issued under Section 14(8) of the Maharashtra Universities Act, 1994.)

Whereas, the Maharashtra Universities Act 1994, i.e. Maharashtra Act No. xxxv of 1994, has come into force with effect from 21st July 1994;

AND

Whereas, the above mentioned Act has been made applicable to the Gondwana University, Gadchiroli from the date of its establishment;

AND

Whereas, Direction No. 178 of 2015 in respect of “Direction governing onscreen revaluation of answer book of examinee appearing of the university examination” was issued by the then Acting Vice-Chancellor under provision of sub-section(8) of section 14 of the above mentioned Act;

AND

Whereas, procedure for application for online hard copy of assessed answer book is prescribed under para 5 of the Direction No. 178 of 2015;

AND

Whereas, procedure for challenge to valuation is prescribed under para 11 of the Direction No. 178 of 2015;

AND

Whereas, fees for online hard copy of assessed answer book and fees for challenge to valuation are not prescribed in the Direction No. 178 of 2015;

AND

Whereas, fees for online hard copy of assessed answer book and fees for challenge to valuation are prescribed by Notification No. GUG/ACAD/CTV/Fee/260/2015 dated 4/7/2015, issued by the then Acting Vice-Chancellor; as Rs. 300/- for photo copy of assessed answer book(onscreen) and Rs. 150/- for challenge to valuation;

AND

Whereas, the Management Council, in its meeting held on 7th October, 2016 vide item No. 3 on the Agenda, has resolved for restructuring of the fees relating to online hard copy of assessed answer book to be issued to an examinee and relating to challenge to valuation as Rs.150/- and 150/- respectively;

AND

Whereas, above mentioned fees are to be incorporated in the existing Direction No. 178 of 2015;

AND

Whereas, application of Notification No. GUG/ACAD/CTV/Fee/260/2015 dated 2015 is to be cancelled;

AND

Whereas, matter is required to be regulated by an ordinance and no ordinance is made in the university by converting Direction No. 178 of 2015 into an Ordinance;

AND

Whereas, making of an Ordinance by converting Direction No. 178 of 2015 into an Ordinance is a time consuming process;

AND

Whereas, the fees prescribed by the Management Council are to be made applicable for examinees who appeared in winter 2016 examinations;

AND

Whereas, to regulate the matter relating to the fees re-structured by the Management Council in its meeting dated 7/10/2016, it is necessary to amend the provisions made under paras 5 and 11 of Direction No. 178 of 2015;

AND

Whereas, it is also necessary to cancel the effect and application of the provisions prescribed in Notification No. GUG/ACAD/CTV/FEE/260/2016, dated 4/7/2015 issued by the Acting Vice-Chancellor.

Now, therefore, I, Dr. N.V. Kalyankar, Vice-Chancellor, Gondwana University, Gadchiroli, in exercise of the Powers vested in me under provisions of sub-section(8) of section 14 of the Maharashtra Universities Act, 1994, do hereby issue following Direction to amend Direction No. 178 of 2015:-

1. This Direction shall be called “Direction governing onscreen revaluation of the answer books of examinees appearing for the university examinations(Amendment), Direction, 2016.”
2. This Direction shall come into force with effect from the date of its issuance.
3. In clause(vii) of para 5 of Direction No. 178 of 2015 in respect of Direction governing onscreen revaluation of the answer books of examinees appearing of the university examinations,(hereinafter referred to as the main Direction) after the words and sign “non-refundable fee” and before the words “per answer book”, the words, figure and signs “of Rs.150/-“ be inserted.
4. In clause(a) of sub-para (ii) of para 11 of the main Direction:-
 - i) after the words “Requisite fee” and before the words and sign “in cash/DD”the words, signs and figure “of Rs. 150/-“ be inserted;
 - ii) the signs and words “/notified/modified from time to time” be deleted;
 - iii) the word “The” appearing after the word ‘for’ and before the words and sign “answer book(s)” be substituted by the word “per”;
 - iv) the word and sign “book(s)” be substituted by the word”book”; and
 - v) the Sign and figure “(8)” be substituted by the figure “8”
5. Notification No. GUG/ACAD/CTV/Fee/260/2015 dated 4 th July, 2015 shall stand cancell.
