

 **GONDWANA UNIVERSITY, GADCHIROLI.**

Direction No. 31 of 2017.

(Under section 71 (17) of the Maharashtra Public Universities Act, 2016.)

Norms and Procedure to be followed while nominating members on authorities, boards and committees by the Vice-Chancellor under the Maharashtra Public Universities Act, 2016 (Excluding nominations under section 32 (3) (f) of the Act) Direction, 2017.

(Issued u/s 12 (8) of the Maharashtra Public Universities Act, 2016)

Whereas, the Maharashtra public Universities Act, 2016 i.e. Maharashtra Act No. VI of 2017 has been made effective from 1st March 2017 to all non-Agricultural universities situated in the State of Maharashtra;

AND

Whereas, the said Act is applicable to Gondwana University, Gadchiroli from the date of its coming into force i.e. from 1st March 2017,

AND

Whereas, different authorities of the university are provided under section 26 of the said Act;

AND

Whereas, board and committees are also provided in the said Act;

AND

Whereas, constitution of different authorities is also provided under different sections of the said Act;

AND

Whereas, constitution of Board and committees is also provided under the said Act;

AND

Whereas, for constituting different authorities of the university, Boards and committees, provisions are made under the Act for nominating members on the different authorities, Boards and committees by the Vice-Chancellor of the university;

AND

Whereas, provisions of following section of the Act are for nominating members on the different authorities, Boards and committees by the Vice-Chancellor of the university;

AND

Whereas, nominations to be made by the Vice-Chancellor under provision of section 32(3)(f) (i),(ii), and (iii) of the Act shall be as per the recommendations of the search committee in consultation with the Chancellor for which Direction No. 30 of 2017 in respect of "Norms and Procedure for nominating members on the Academic Council by the Vice-Chancellor, as per the recommendations of the search committee, in consultation with the Chancellor Direction, 2017 is issued by the Vice-Chancellor on 04/09/2017 under provision of section 12(8) of the Act;

AND

Whereas, matter relating to nomination by the Vice-Chancellor on the authorities, boards and committees is required to be regulated by the Statute as provided under section 71 (17) of the Act;

AND

Whereas, no Statute is prepared in the university for regulating the matter relating to nomination of members by the Vice-Chancellor On the authorities, boards and committees;

AND

Whereas, there is an emergency for nominating the members on the authorities boards and committees by the Vice-Chancellor for constituting the said authority/board/committee.

Now, therefore, I, Dr. N. V. Kalyankar, Vice-chancellor, Gondwana University, Gadchiroli in exercise of the powers conferred upon me under provision of section 12(8) of the Maharashtra Public Universities Act, 2016, do hereby issue following Directions: -
