DIRECTION NO. 19 OF 2022

### ADMISSION TO FULL TIME POST-GRADUATE COURSES IN UNIVERSITY TEACHING DEPARTMENT DIRECTION, 2022.

(Issued under provision of Section 12(8) of the Maharashtra Public Universities Act, 2016)

**Whereas**, the Maharashtra Public Universities Act, 2016(Maharashtra Act No. VI of 2017) has come into force with effect from 1st March 2017;

AND

**Whereas**, the Maharashtra Public Universities Act, 2016 has repealed to Maharashtra Universities Act,1994 with effect from 1st March 2017;

AND

**Whereas**, the Gondwana University, Gadchiroli was established by Government of Maharashtra vide Notification No. MISC-2010/ (252/10) UNI – 4 Dated 27th September, 2011 as a State University Governed by the Maharashtra Universities Act, 1994;

AND

**Whereas**, the Gondwana University, Gadchiroli has started functioning by way of offering various academic courses commencing from the session 2012-13;

AND

**Whereas**, the Government of Maharashtra vide its G.R. No. T.E.M- 2015/Pra. Kra. 325/Tashi-4, dt 20<sup>th</sup> July 2016 has directed the Universities in the State of Maharashtra to introduce the system of Admission Process for the post- graduate courses in the University;

AND

**Whereas**, to implement the decision of the government to introduce admission process in the University, the Vice-Chancellor had constituted a committee to study and suggest the Draft Regulations for regulating admissions to the post graduate courses in the post graduate teaching departments of the University;

AND

**Whereas**, section 75(1)(c) of the Maharashtra Public Universities Act, 2016 (hereinafter "the Act") provides for framing of the Regulations laying down conditions for admission of students for various courses of the University;

AND

**Whereas**, as per the Government of Maharashtra's Circular No. Sankirna-2019/Pra.kra.22/vishi-3 dt. 08<sup>th</sup> March, 2019, reservation to the people belonging to the Maratha and Socially and Educationally Backward Category (S.E.B.C.) and also to the economically weaker section of people belonging to the open category is required to be given for admission of students in the educational institutions of the non-agricultural Universities within the State of Maharashtra;

AND

**Whereas**, the reservation of seats for admitting students to the full time post-graduate courses in university's Post-graduate Teaching departments, post-graduate conducted colleges and institutions is also required to be done from the academic session from 2019-20 in terms of the महाराष्ट्र शासन परिपत्रक क्र. संकिर्ण - २०१९/ प्र. क्र.२२/विशी.३ dt. 08<sup>th</sup> March, 2019;

AND

**Whereas**, Direction No. 15 of 2020 in respect of "Admission to Full Time Post-Graduate Courses in University Teaching Departments Direction, 2020" was issued by the Vice-Chancellor on 5/11/2020 under the provision of sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016;

AND

**Whereas**, as per the Government of Maharashtra's Circular No. Sankirna-1020/Pra.kra.127/mashi-2 dtd. 11<sup>th</sup> September'2020, admission of students for the academic year 2020-21 in the educational institutions of the non-agricultural Universities within the State of Maharashtra be provided as if the SEBC Act is not in force i.e. admission process be implemented without applying the provisions of SEBC Act (Maratha reservation);

AND

**Whereas**, the above stated Direction No. 15 of 2020 is automatically lapsed on dated 4<sup>th</sup> May'2021;

AND

**Whereas**, preparing ordinance in the above said matter is a time consuming process;

AND

**Whereas**, it is expedient to re-issue the Direction No 15 of 2020 considering the exigency of the situation;

AND

**Whereas**, Direction No. 14 of 2021 in respect of "Admission to Full Time Post-Graduate Courses in University Teaching Departments Direction, 2021" was issued by the Vice-Chancellor on 3/09/2021 under the provision of sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016;

AND

**Whereas**, the above stated Direction No. 14 of 2021 is automatically lapsed on dated 2<sup>nd</sup> March'2022;

AND

**Whereas**, preparing ordinance in the above said matter is a time consuming process;

AND

**Whereas**, it is expedient to re-issue the Direction No 14 of 2021 considering the exigency of the situation;

AND

**Whereas**, the matter is required to be executed with immediate effect;

Now, therefore, I, Prof. Dr. Prashant S. Bokare, Vice-Chancellor, Gondwana University Gadchiroli, in exercise of my powers under section 12(8) of the Act, do hereby issue the following Directions.

1. This Direction shall be called "ADMISSION TO FULL TIME POST- GRADUATE COURSES IN UNIVERSITY'S TEACHING DEPARTMENT AMENDMENT, DIRECTION, 2022".
2. This Direction shall come into force with effect from the date of its issuance;
3. Notwithstanding anything to the contrary in any other Directions of the University, the admission to post graduate degree courses in all the four faculties, except those courses for which admission is regulated by the centralised admission process (CAP) of the State Government of Maharashtra, in all the post graduate teaching departments of the University, shall be regulated by this Direction.
4. Definitions:-In this Direction unless the context requires otherwise, the words and phrases shall have the meaning given hereunder.
  - a) "Act" means the Maharashtra Public Universities Act 2016.
  - b) "Application Form" means prescribed form filled up by the Candidate for admission.
  - c) "Competent Authority" means the Authority appointed by the Vice-Chancellor, for the purposes of this Direction.
  - d) "Courses" means the full time Postgraduate courses in the University.
  - e) "Department" means Post Graduate Teaching Department of the University.
  - f) "Foreign Student" means a person who is citizen of a country other than India.
