

## **DIRECTION NO. 190 OF 2016.**

**Examinations leading to the Degree of Master of Technology (Two year post graduate program with semester pattern and credit grade system) in the faculty of Engineering and Technology, (Amendment) Direction, 2016.**

( Issued u/s. 14 (8) of the Maharashtra universities Act, 1994.)

**Whereas,** Direction namely Direction Governing Examinations leading to the Degree of Master of Technology (Two year post graduate program with semester pattern and credit grade system) in the faculty of Engineering and Technology, is in existence in the university bearing Direction No. 149 of 2012;

AND

**Whereas,** the above mentioned Direction No. 149 of 2012 was required to be converted into an ordinance to be made in that behalf;

AND

**Whereas,** Direction No. 149 of 2012 is yet not converted into an ordinance;

AND

**Whereas,** the provisions made in Direction No. 149 of 2012 are regulating the Master of Technology (Two year post graduate program with semester pattern and credit grade system) course (Admissions and Examinations) in the university;

AND

**Whereas,** admissions to M. Tech. specializations program are made on the basis of eligibility conditions prescribed under column No. 3 of the table 2 provided under para 6 of Directions No. 149 of 2012 which has a reference in para 6 a) iii) of the said Direction;

AND

**Whereas**, the Academic council in its meeting held on 26/11/2015, vide item No. 5 on the Agenda, has resolved to introduce 'B.E. Electrical Engineering (E & P)' as an eligibility condition to take admission in M. Tech. (I<sup>st</sup> year) Electrical power system specialization and 'B.E. (production Engineering)' as an eligibility condition to take admission in M. Tech. ( I<sup>st</sup> year) Heat power Engineering specialization.

AND

**Whereas**, provision of para 6, a), iii) of Direction No. 149 of 2012 is required to be amended;

AND

**Whereas**, converting the Direction No. 149 of 2012 into an ordinance and making amendment in that ordinance, according to the decision of the Academic council, is a time consuming process;

AND

**Whereas**, the matter is required to be regulated urgently by making amendment in the existing Direction No. 149 of 2015.

Now, therefore, I, Dr. N. V. Kalyankar, Vice-Chancellor, Gondwana university, Gadchiroli in exercise of the powers vested in me vide sub-section (8) of section 14 of the Maharashtra universities Act, 1994 do hereby issue following directions to amend Direction No. 149 of 2012 :-

1. This Direction may be called "Examinations leading to the Degree of Master of Technology (Two year post graduate program with semester pattern and credit grade system) in the faculty of Engineering and Technology, (Amendment) Direction, 2016"
2. This Direction shall come into force with effect from the date of its issuance.

3. In 'Table 2' relating to eligibility criteria for admission to M.Tech. courses, provided Vide sub-clause 'iii)' of clause 'a)' of para 6 of Direction No. 149 of 2012 in respect of 'Direction Governing Examinations leading to the Degree of Master of Technology (Two year post graduate program with semester pattern and credit grade system) in the faculty of Engineering and Technology, 2012 (hereinafter referred to as the main Direction)

1) In column relating to " Eligibility qualification B.E./B.Tech. of the affiliate university or any other statutory university recognized equivalent thereto OR AMIE in following Disciplines of Engineering and Technology" of Table 2 provided vide para 6 a) iii) of the main Direction :-

(a) The sign and words '/Production Engineering' be added after the words 'Power Engineering' against Sr. No. 4 relating to 'Heat power Engineering; and

(b) The signs and words '/Electrical Engineering (E & P) be added after the words 'Power Electronics Engineering' against Sr. No. 6 relating to Electrical power system.
