GONDWANA UNIVERSITY, GADCHIROLI DIRECTION NO. 5 OF 2017

EXAMINATIONS LEADING TO THE DEGREE OF MASTER OF COMPUTER APPLICATION(M.C.A.) SEMESTER PATTERN WITH CHOICE BASED CREDIT SYSTEM, DIRECTION, 2017.

(Issued under Section 12(8) of the Maharashtra Public Universities Act, 2016.)

Whereas, The Maharashtra Public Universities Act, 2016 has come into force with effect from 1 st March 2017; (hereinafter reffered to as the Act)

AND

Whereas, the Act has been made applicable to the Gondwana University, Gadehiroli from the date of its enactment;

AND

Whereas, Ordinance No. 83 of 2017 in respect of Examinations leading to the Degree of Master of Computer Application(M.C.A.) semester pattern with choice based credit system, Ordinance,2017 is made by the Management Council;

AND

Whereas, the State Common entrance test cell of the Government of Maharashtra, Mumbai has changed the eligibility criteria for appearing to MAH-MCA-CET 2017 vide its No.CETCELL/MCA-Notice-1/2017/57 dated 2/02/2017;

AND

Whereas, the eligibility criteria for appearing to MAH-MCA-CET 2017 noticed by the state common entrance test cell of the Govt. of Maharashtra Mumbai is to be made applicable for admission to M.C.A. part-I(1st semester)from the Academic session 2017-18;

AND

Whereas, the eligibility criteria for Direct admission to MCA Part II(3 rd semester) from the Academic session 2017-18 is also changed by the state common entrance test cell of the Maharashtra Government, Mumbai;

AND

Whereas, the eligibility criteria which has been changed by the state common entrance test cell Maharashtra, Mumbai mentioned in the above paras is to be made applicable for admission to the 1st semester of M.C.A. course as well as for direct admission to 3rd semester of the M.C.A. course from the Academic Session 2017-18;

AND

Whereas, Notice No. CETCELL/MCA-Notice-1/2017/57 dated 2/02/2017 received from the state common entrance test cell, Maharashtra, Mumbai has

been accepted by the vice-chancellor under provision of section12(7) of the Maharashtra Universities Act, 2016 on behalf of the Academic Council and the Management Council on 14/03/2017 respectively;

AND

Whereas, the matter is required to be regulated by an ordinance;

AND

Whereas,an Ordinance No. 83 of 2017 is required to be amended for regulating the matter related to eligibility criteria for admissions to 1 st and 3 rd semester of M.C.A. course form the Academic session 2017-18;

AND

Whereas, amending ordinance No. 83 of 2017 for making addition to the eligibility criteria is a time consuming process;

AND

Whereas, the matter is to be implemented for admission to 1 st and 3 rd semester of the M.C.A. course form the Academic session 2017-18;

Now, therefore, I,Dr. N.V. Kalyankar, Vice-chancellor, Gondwana University, Gadchiroli in exercise of the powers conferred on me under provision of subsection(8) of section 12 of the Maharashtra Public University Act,2016, do hereby issue following Directions:-

- 1. This Direction shall be called "Examinations leading to the Degree of Master of Computer Application(M.C.A.) semester pattern with choice based credit system, Direction,2017."
- **2.** This Direction shall come into force with effect from the date of its issuance.
- 3. 'Eliligibility for the Course' mentioned under para '6' of an Ordinance No. 83 of 2017 in respect of Examinations leading to the Degree of Master of Computer Application(M.C.A.) semester pattern with choice based credit system,Ordinance, 2017.i.e. 'Eligibility:- under clauses a) and b)' be substituted by the eligibility criteria mentioned below:-

"Eligibility criteria for appearing to MAH-MCA-CET and for admission to MCA. Part –I(Semester I & II courses and Examinations):-

- a) Candidate having valid CET Score(i.e.- candidate securing Zero or negative marks in MAH-MCA-CET or any other equivalent CET will not be considered eligible for the admission) and fulfill the following eligibility criteria-
 - (i) The candidate should be an Indian National;
 - (ii) Passed minimum three year duration Bachelor's Degree awarded by university recognized by U.G.C. or A.I.U. in any discipline with at least 50% marks in aggregate(Aggregate marks means the grand total of marks obtained by the candidate in subjects based on which a class declaration is made in the particular university from which the candidate

is passing the qualifying examination) or equivalent(at least 45% in case of candidates of backward class categories and person with Disability belonging to Maharashtra State only;

- (iii)Studied Mathematics as one of the subjects at (10+2) level or at graduate level examination.
- b) Direct admission to M.C.A. Part II(Semester III):- The candidate should have passed Bachelor Degree in computer Application or science(Information Technology or Computer Science)

OR

The candidate should have passed the PGDCS&A Examination of the university or of R.T.M. Nagpur university Nagpur.

This direct admission shall be subject to satisfaction of other norms and availability of seats in the institution running M.C.A. Course."
