

# **GONDWANA UNIVERSITY, GADCHIROLI**

## **Direction No.196 of 2016**

### **NORMS AND PROCEDURE FOR GRANTING AFFILIATION TO COLLEGE BY THE UNIVERSITY, DIRECTION, 2016.**

**(Issued under provision of section 14(8) of the Maharashtra universities  
Act,1994)**

Whereas, the Maharashtra universities Act, 1994, i.e. Maharashtra Act No. XXXV of 1994, has come into force with effect from 21<sup>st</sup> July 1994;

**AND**

Whereas, the above said Act has been made applicable to Gondwana University, Gadchiroli with effect from 2<sup>nd</sup> Oct. 2011;

**AND**

Whereas, sections 81 to 92 of the above said Act are relating to permission, affiliation and recognition to college and institution;

**AND**

Whereas, sub-section(10) of section 51 of the above said Act provides that statute may be provided for the norms of affiliation of colleges or for withdrawing the affiliation of the colleges;

**AND**

Whereas, the university Grants Commission has framed Regulation in respect of U.G.C.(Affiliation of colleges by the universities) Regulations 2009 which was published in the Gazette of India dated 20/02/2010 in English and Hindi;

**AND**

Whereas, Section officer, Higher and Technical education Department, Mumbai vide letter No. sankirna 2009/(185/10)/UE-3 date 19/06/2010 has forwarded the copy of U.G.C.(Affiliation of colleges by universities Regulations, 2009 to the Registrar, Non-Agricultural universities in Maharashtra state for necessary action;

**AND**

Whereas, the said U.G.C.Regulations 2009, was amended by 1<sup>st</sup> amendment which is known as U.G.C.(Affiliation of colleges by universities)(1<sup>st</sup> Amendment) Regulation, 2012 which was published in the Gazette of India(Extra ordinary) part-III –section-4 dated 26<sup>th</sup> March 2012 Vide Notification No. F.1-7/2007(CPP-1/c)dated 20<sup>th</sup> April 2012 and the copy has been forwarded to the universities of the said Regulation,2012;

**AND**

Whereas, the Vice-Chancellor has accepted both Regulations i.e. Regulations 2009 and Regulation 2012 of the U.G.C. on behalf of the Academic Council and the Management Council under provision of section 14(7) of the Maharashtra universities Act,1994;

**AND**

Whereas, no statute is provided for the norms and procedure for granting affiliation to the college by the university;

**AND**

Whereas, the matter is required to be regulated by the statute;

**AND**

Whereas, preparing and passing of the statute by the senate and assented to it by the chancellor is time consuming process;

**AND**

Whereas, the matter is required to be regulated urgently;

**AND**

Whereas, it is found expedient to issue Direction to regulate the matter,

Now, therefore, I, Dr. N.V. Kalyankar, Vice-Chancellor, Gondwana University, Gadchiroli in exercise of the powers vested in me under provision of section 14(8) of the Maharashtra universities Act, 1994, do hereby issue the following Directions:-

1. This Direction may be called, "Norms and procedure for granting affiliation to college by the university, Direction, 2016."
2. This Direction shall come into force with effect from the date of its issuance.
3. In this Direction, unless the context otherwise requires:-
  - a) 'Act' means the Maharashtra universities Act, 1994.(Maharashtra Act No. XXXV of 1994).

b) 'Regulations' means the university Grants Commission(Affiliation of colleges by the universities)Regulations 2009 and university Grants commission[Affiliation of colleges by universities](1<sup>st</sup> Amendments) Regulations, 2012.

4. For prescribing norms to grant affiliation to the college by the university, the university Grants commission(Affiliation of college by Universities)Regulations, 2009 and University Grants Commission[Affiliation of college by universities](1<sup>st</sup> Amendments) Regulations, 2012 have been issued which is appended herewith in consolidated form as Appendix-I of this Direction and shall hereinafter be applicable.

Provided firstly that the provisions made under U.G.C.(Affiliation of colleges by universities)(1<sup>st</sup> Amendments)Regulations,2009 inclusive of U.G.C.[Affiliation of colleges by universities](1<sup>st</sup> Amendments) Regulations, 2012 (Appendix-I) appended with this Direction which are not consistent with the provisions made under Sections 81 to 92 of the Act shall be treated as null and void.

Provided secondly that the terms which are not mentioned in U.G.C.(Affiliation of colleges by universities) Regulations 2009 and U.G.C.[Affiliation of colleges by universities](1<sup>st</sup> Amendments) Regulations, 2012 (Appendix-I) shall be as per the provisions of the Act.
