(Issued under provision of section 12(8) of the Maharashtra Public Universities Act, 2016)

DIRECTION TO AMEND CERTAIN ORDINANCES RELATING TO CONDUCT OF POST GRADUATE EXAMINATIONS IN DIFFERENT FACULTIES, DIRECTION, 2018.

Whereas, the Maharashtra Public Universities Act, 2016 has come into force with effect from 1st March 2017 (hereinafter referred to as the Act);

AND

Whereas, the Act has repealed the Maharashtra Universities Act, 1994 with effect from 1st March 2017;

AND

Whereas, the Act has been made applicable to the Gondwana University, Gadchiroli with effect from 1st March 2017;

AND

Whereas, following ordinances are made by the Management Council for conduct of Post Graduate Examinations for the courses involved in the related ordinance ;

Whereas, Choice Based Credit System is made applicable for all Post Graduate Degree Examinations in all the Faculties in the university;

AND

Whereas, CGPA final grade table is not provided in some ordinance or CGPA final grade table is provided in some ordinances but there is no Symmetry in the said provided final grade table;

AND

Whereas, to bring Symmetry in the CGPA final grade table in all the Post Graduate Degree Examinations for with Choice Based Credit System is made applicable, the meeting of all Deans of the faculties in the university was organized on 26/06/2018;

AND

Whereas, Deans of the faculties of Science and Technology, Humanities and Commerce and Management have recommended following CGPA final grade table for its inclusion in the ordinances of Post Graduate Degree courses examinations where forty percent passing is provided and choice based credit system is applicable to the Examinations ;

Whereas, CGPA final grade table recommended by the Deans' committee in its meeting held on 26/06/2018 has been accepted by the vice-chancellor under provision of section 12(7) of the Maharashtra Public Universities Act, 2016 on behalf of the faculties of Science and Technology, Humanities, Commerce and Management and Inter-Disciplinary Studies and the Academic Council, on 5/07/2018;

AND

Whereas, CGPA final grade table is required to be added/inserted/substituted, as the case may be, in the ordinances relating to Post Graduate Degree Course Examinations in all faculties in the university relating to choice based credit system and where forty percent minimum passing is provided for the examination;

AND

Whereas, making amendment by adding/inserting/substituting, as the case may be, CGPA final grade table in the related Post Graduate Degree Examination ordinance is time consuming process;

AND

Whereas, the results of the Final year Post Graduate Degree Courses are to be declared by awarding grade to the examinees;


Now, therefore, I, Dr. N. V. Kalyankar, Vice-Chancellor, Gondwana University, Gadchiroli, in exercise of the powers vested in me under provision of sub-Section (8) of section 12 of the Maharashtra Public Universities Act, 2016, do hereby issue the following Directions: -

1. This Direction may be called "Direction To Amend Certain Ordinances Relating to Conduct of Post Graduate Examinations In Different Faculties Direction, 2018."
2. This Direction shall come into force with effect from the date of its issuance.
3. **'CGPA FINAL GRADE TABLE' mentioned below be added /Inserted/Substituted at the appropriate place, as the case may be in Ordinance Nos 74 of 2017,75 of 2017, 76 of 2017, 78 of 2017,79 of 2017(Excluding Mathematics), 80 of 2017, 81 of 2017 and 83 of 2017, for declaring the results of the final year of Post Graduate Examinations relating to the above mentioned ordinances.**
