# GONDWANA UNIVERSITY, GADCHIROLI

# Direction No. 192 of 2016

NATIONAL COUNCIL FOR TEACHER EDUCATION (RECOGNITION NORMS AND PROCEDURE) REGULATIONS, 2014, DIRECTION , 2016.

(Direction issued under provision of Section 14(8) of the Maharashtra Universities Act, 1994)

Whereas, the Maharashtra Universities Act, 1994 i.e. Maharashtra Act, No. XXXV of 1994, (hereinafter referred to as the Act)has come into force with effect from 22<sup>nd</sup> July 1994;

#### AND

Whereas, the Gondwana University, Gadchiroli has been established with effect from 2-10-2011;

#### AND

Whereas, National Council for Teacher Education, established under the National Council for Teacher Education Act, 1993(73 of 1993), has made the National Council for Teacher Education(Recognition Norms and Procedure0 Regulations, 2014 and notified it by No. F.51-1/2014-NCTE(N&S) dated 28<sup>th</sup> November, 2014 in the Gazette of India-Extraordinary [PART III SEC. 4]

#### AND

Whereas, the Deputy Secretary, Higher & Technical Education Department, Maharashtra Government, Mumbai vide his letter No. B.Ed.4615/P.K.262(2)Mashi-2 dated 30<sup>th</sup> May 2015, directed the Director, Higher Education, Maharashtra state, Pune to inform all permanent unaided education colleges and/or physical education colleges to implement the National Council for Teacher Education(Recognition Norms and Procedure) Regulation, 2014;

#### AND

Whereas the Joint Director, Higher Education, Nagpur Division, Nagpur with reference to government letter No.B.Ed.4615/P.K.262(2)/Mashi2, dated 30<sup>th</sup> May 2015 and Director, Higher Education, Maharashtra State, Pune's letter No. H.E.D/2015/P.K.262(2) B.Ed./6066 dated 18/06/2015 vide letter No. H.E.NAG/B.Ed./3600/15 dated 23<sup>rd</sup> June 2015, informed the Registrar of the University to instruct all permanent unaided education college and physical education college affiliated with the university to implement the National

Council for Teacher Education(Recognition Norms and Procedure) Regulations, 2014;

#### AND

Whereas, the Vice-Chancellor, Gondwana University, Gadchiroli on behalf of the Academic Council, on dated 22/04/2016, & the Management Council on dated11/07/2016 has adopted the National Council for Teacher Education,(Recognition Norms and Procedure), Regulations, 2014, for its implementation;

#### AND

Whereas, norms of affiliation of colleges or for withdrawing the affiliation of colleges is a subject matter of the statute as provided under sub-section(10) of section 51 of The Maharashtra Universities Act, 1994;

## AND

Whereas, the National Council for Teacher Education(Recognition Norms and Procedure)Reguations,2014 provides for its applicability to all matters relating to teacher education programmes for preparing norms and standards and procedure for recognition of colleges/institution, commencement of new programmes and addition to sanction intake in the existing programmes including recognition for commencement of new teacher education programmes which shall be offered in composite institution/colleges, permission for existing teacher education programme in introduction of new institutions/colleges duly recognized by the Council, permission for additional intake in the existing teacher education programmes duly recognized by the Council, permission for shifting or relocating of premises of existing teacher education institution/colleges and permission for closure or discontinuation of recognized teacher education programmes or institutions/colleges, as the case may be;

## AND

Whereas, the matter, referred at above para, is required to be regulated by the Statute;

#### AND

Whereas, no statute is prepared for the matter included in the National Council for Teacher Education(Recognition Norms & Procedure)Reguations,2014;

#### AND

Whereas, preparing of the Draft Statute, passing it by the senate it by the senate and assenting to it by the Chancellor is time consuming process;

# AND

Whereas, National Council for Teacher Education(Recognition Norms and Procedure), Regulations, 2014 is to be implemented with immediate effect.

Now, therefore, I, Dr.N.V. Kalyankar, Vice-Chancellor, Gondwana University, Gadchiroli in exercise of the powers vested in me under provision of Section 14(8) of the Maharashtra Universities Act, 1994, do hereby issue following Direction:-

- 1. This Direction shall be called National Council for teacher education (Recognition Norms and procedure) Regulations, 2014, Direction, 2016" (hereinafter referred to as Direction).
- 2. This Direction shall come into force with effect from the date of of its issuance.
- 3. In this Direction, unless the context otherwise requires :
  - a. "act means the Maharashtra Universities Act, 1994 (Maharashtra Act No. xxxv of 1994) (hereinafter referred to as Act);
  - b. "Affiliated college" means a college which has been granted affiliation by the university;
  - c. "Closure" means discontinuation of recognition of programmes or institution or college permitted by the Council on the basis of a formal application submitted by the institution/college.
  - d. "College" means a college conducted by university, or affiliated to the university, situated in the university area;
  - e. "Composite institution" means a duly recognized higher education institution offering undergraduate or post-graduate programmes of study in the field of liberal arts or humanities or social sciences or commerce or mathematics, as the case may be, at the time of applying for recognition of teacher education programmes, or an institution offering multiple teacher education programmes;
  - f. "Conducted college" means a college maintained and managed by the university;
  - g. "Diploma/Degree/Post-Graduate Degree programmes" means the programme relating to Diploma/Degree/Post-Graduate Degree course mentioned under Appendices 1 to 15 in the National

Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2014;

- h. "Director" means a head of an institution including a centre, or a school of the university as designated by the Management Council;
- i. "Institution" means an academic institution of higher learning, not being a college, associated with and admitted to the privileges of the university;
- j. "Management" means the trustees or the managing or governing body, by whatever name called, of any trust registered under the Bombay Public Trusts Act, 1950 or any society registered under the Societies Registration Act, 1860;
- k. "National Council for Teacher Education" means the council constituted as per the provision of the National Council for Teacher Education Act, 1993 (73 of 1993);
- 1. "Post-Graduate Department" means a department in a college or institution of higher learning, research or specialized studies, recognize to be so by the university and imparting post-graduate instruction or guidance or research;
- m. "Principal" means a head of a college, specialized educational institution, post-graduate centre or other recognize institution duly approved by the university;
- n. "Recognized institution" means an institution of higher learning, research or specialized studies, other than a college, and recognized to be so by the university;
- o. "Regulations" means the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2014;
- p. "Teacher" means full-time approved professor, associate professor, assistant professor, reader, lecturer, librarian, principal, deputy or assistant librarian and documentation officer in the university and college librarian, Director or Instructor of physical education in any university department, conducted affiliated or autonomous college, autonomous institution or department or recognized institution in the university;
- q. "University" means the Gondwana University, Gadchiroli mentioned in the schedule of the Act;
- r. "University department" means a department established and maintained by the university;
- s. "University institution" means a centre, a school, or an institute established and maintained by the university;
- t. "University teacher" means a teacher appointment by the university;

- t. "University teacher" means a teacher appointment by the university;
- 4. The National Council for Teacher Education (Recognition Norms and Procedure) Regulation, 2014 shall be applicable to be permanent unaided teacher education/physical education colleges/institution affiliated to the university/to be affiliated to the university regarding all matters relating to teacher education programmes or preparing norms and standards and procedure for recognition of institutions/colleges, commencement of new programmes and addition of sanctioned intake in the existing programmes alongwith recognition for commencement of new teacher education programmes which shall be offered in composite institution/colleges, permission for introduction of new programmes in existing teacher education institutions/colleges duly recognized by the Council, permission for shifting or relocating of premises of existing teacher education institution/colleges and permission for closure or discontinuation of recognized teacher education programmes or institutions/colleges as the case may be which is annexed with this statute as ANNEXURE-A, printed in the Gazette of India-Extraordinary [PART III-SEC 4] bearing page Numbers 92 to 178 including Appendices 1 to 15 relating to Diploma/Degree/Post-Graduate Degree programmes.
