Direction No.37of 2017

Prescribing Procedure, to be adopted, for nominations for the elections (Amendment) Direction, 2017.

(Issued under provision of Section 12 (8) of the Maharashtra Public Universities Act, 2016)

Whereas, the Maharashtra public Universities Act, 2016 has come into force with effect from 1st March 2017. (Maharashtra Act No. VI of 2016) (hereinafter referred to as the Act),

AND

Whereas, the Act has been made applicable to the Gondwana University. Gadchiroli from the date of its coming into force i.e. from 1st March 2017;

AND

Whereas, the university has to conduct elections for electing persons who shall be the members of the university authorities namely, the Senate, the Academic Council, and the Boards of Studies;

AND

Whereas, for smoothly conduct of elections of the authorities, the procedure based on the provision made under uniform statute No. 1 of 2017 is required to be prescribed;

AND

Whereas, Statute relating to elections are in existence in the university but the provisions made under these statutes are not consistent with the provisions made under the Act;

AND

Whereas, sub-section (13) of section 71 of the Act provides that the procedure for conduct of elections to various authorities and bodies is required to be regulated by the Statutes;

AND

Whereas, the process for amending the existing statute was time consuming one;

AND

Whereas, the Vice- Chancellor, on 01-07-2017, has issued Direction under provision of section 12 (8) of the Maharashtra Public Universities Act, 2016 in respect of "Prescribing Procedure, to be adopted, for nominations for the elections Direction, 2017." having number Direction No. 9 of 2017;

AND

Whereas, in Direction No. 9 of 2017, Direction No. 9-O of 2017 is provided relating to Prescribing Procedure, to be adopted, for Nominations for Elections Direction, 2017;

AND

Whereas, provisions made under Direction No. 9-O of 2017 are partially inconsistent with the provisions made under Direction No. 9-I of 2017;

AND

Whereas, it necessary to remove the inconsistency appearing in Direction No. 9-O of 2017, Direction No. 9-O of 2017 is required to be amended;

AND

Whereas, Direction No. 9 of 2017 is yet to be converted into the Statute as provided under Section 12(8) of the Maharashtra Public Universities Act, 2016;

AND

Whereas, there is an emergency to amend Direction No 9-O of 2017 for removing the inconsistency appearing in it;

Now, therefore, I, Dr. N. V. Kalyankar, Vice- Chancellor, Gondwana University, Gadchiroli in exercise of the powers conferred upon me under provision of Section 12 (8) of the Maharashtra Public Universities Act, 2016, do hereby issue following Directions to amend Direction No. 9-O of 2017 in respect of 'Prescribing Procedure, to be adopted, for Nominations for the Elections Direction, 2017.'

- 1 This Direction may be called "Prescribing Procedure, to be adopted, for nominations for the elections (Amendment) Direction, 2017"
- 2 This Direction shall come into force with effect from the date of its issuance

3 In Direction No. 9-O of 2017 in respect of “Prescribing Procedure to be adopted for nominations for the elections Direction, 2017”, proformas for nomination for the elections to the authorities of the university are provided under ANNEXURE-I,II,III,IV, V, VI and VII with reference to para 4 of the said Direction.

- i) Under ANNEXURE-I, ‘Nomination Paper’ for election of 10 principals of Affiliated, Conducted, Autonomous colleges to the Senate, from amongst the collegium of the Principals and documents to be enclosed by the candidate with his/her nomination paper is provided under the title “Enclosures”. The said page be substituted by the page Under APPENDIX-1 appended with this Direction.
- ii) Under ANNEXURE-II, ‘Nomination Paper’ for election of 06 Representatives of the Management to the Senate, from amongst the collegium of the Management Representative of the affiliated colleges or institutions and documents to be enclosed by the candidate with his/her nomination paper is provided under the title “Enclosures”. The said page be substituted by the page Under APPENDIX-2 appended with this Direction.
- iii) Under ANNEXURE-III, ‘Nomination Paper’ for election of 10 Teachers other than Principals and Directors of Recognized Institutions to the Senate, from amongst the collegium of teachers and documents to be enclosed by the candidate with his/her nomination paper is provided under the title “Enclosures”. The said page be substituted by the page Under APPENDIX-3 appended with this Direction.
- iv) Under ANNEXURE-IV, ‘Nomination Paper’ for election of 03 Teachers of the University to the Senate, from amongst the collegium of University Teachers and documents to be enclosed by the candidate with his/her nomination paper is provided under the title “Enclosures”. The said page be substituted by the page Under APPENDIX-4 appended with this Direction.
- v) Under ANNEXURE-V, ‘Nomination Paper’ for election of 10 Registered Graduates to the Senate, from amongst the collegium of Registered Graduates and documents to be enclosed by the candidate with his/her nomination paper is provided under the title “Enclosures”. The said page be substituted by the page Under APPENDIX-5 appended with this Direction.

- vi) Under ANNEXURE-VI, 'Nomination Paper' for election of 02 teachers Representing each faculty to the Academic Council, from amongst the collegium of Teachers and documents to be enclosed by the candidate with his/her nomination paper is provided under the title "Enclosures". The said page be substituted by the page Under APPENDIX-6 appended with this Direction.
- vii) Under ANNEXURE-VII, 'Nomination Paper' for election of 03 Heads of Departments of Affiliated Colleges and institutions from , from amongst the collegium of Heads of Department of the affiliated colleges and institutions to the Board of Studies and documents to be enclosed by the candidate with his/her nomination paper is provided under the title "Enclosures". The said page be substituted by the page Under APPENDIX-7 appended with this Direction

Following documents must be enclosed with each Nomination paper: -

- (a) Copy of Valid Certification of Accreditation by National Assessment and Accreditation Council (NAAC) or National Board of Accreditation (NBA), as the case may be, of the college to which the candidate is principal and period of validity of such Certificate Should be unexpired.
- (b) Copy of Ph.D. degree Certificate, if not appointed as a Principal before 13.10.2000.
- (c) Copy of Certificate from the competent officer stating that the candidate has undertaken university examination related work for at least 5 years in aggregate.
- (d) Copy of caste validity certificate issued by the competent authority, if required.

Documents to be enclosed with each Nomination paper: -

Following documents must be enclosed with each Nomination paper.

- (a) Copy of the Bachelor Degree Certificate,
- (b) Copy of the Certificate issued by the chairperson and the Secretary of the Management of the concerning society stating that the candidate is a member of Governing Body/ Management Committee for at least two years.
- (c) Copy of valid Certification of Accreditation by National Assessment and Accreditation Council (NAAC) or National Board of Accreditation (NBA), as the case may be, and period of validity of such Certificate should be unexpired, of the college/Institution run by such Management.
- (d) Copy of caste validity certificate issued by the competent authority, if required.

Documents to be enclosed with each Nomination paper: -

Following documents must be enclosed with each Nomination paper: -

- (a) Copy of the Ph.D. degree certificate and the certificate from the principal stating at least ten years teaching experience in aggregate.

Or

Copy of certificate issued by the Principal of the college stating that the candidate has atleast fifteen years teaching experience in aggregate.

- (b) Certificate from the competent officer stating that the candidate has undertaken examination related work for at least five years in aggregate.
- (c) Copy of caste validity certificate issued by the competent authority, if required.

Following documents must be enclosed with each Nomination paper.

- (b) Copy of certificate, from the officer authorized by the university, stating that the candidate has at least ten years teaching experience in aggregate.
- (c) Copy of Certificate, from the competent officer stating that the candidate has undertaken examination related work for at least five years in aggregate.
- (d) Copy of Caste validity certificate issued by the competent authority; if required.

- (b) Copy of Caste validity certificate issued by the competent authority; if required.

Following documents must be enclosed with each nomination paper.

- a) Copy of Ph.D. Degree certificate,
- b) Copy of the certificate issued by the Principal of the college/ Head of the recognized institution stating that the candidate has at least 15 years aggregate teaching experience.
- (c) Copy of certificate issued by the university as a recognized Ph.D. Guide. Copy of the Ph.D. notifications of at least two research students to whom Ph.D. is awarded.
- (d) Documents showing that the candidate has authored/co-authored at least two text books/reference books or shall have published at least three research papers in peer reviewed journals as first/corresponding author.
- (e) Copy of the certificate from the competent officer stating that the candidate has undertaken examination related work for at least five years in aggregate.
- (f) Copy of caste validity certificate issued by the competent authority; if required.
